

Re: Angel Tax Credit Program

Pursuant to the requirements of Connecticut General Statutes of Public Act 17-110, I am pleased to submit the Cumulative Report for the Angel Tax Credit Program as managed by Connecticut Innovations, Incorporated. The report covers all the Qualified Connecticut Businesses that received funding from Angels through the program from July 1, 2010 through May 31, 2023.

### **ECONOMIC IMPACT**

234 Qualified Connecticut Businesses (QCB's) received \$146M in investments. The QCB's have created or retained over 1,700 jobs as of May 31, 2023. The state has invested \$36.5M via angel tax credits awarded, generating a leverage factor on the program of 4X.

The Angel Tax Credit program was designed to encourage investments in early-stage technology-based businesses in the state. The legislation was revised in 2018 and all business disciplines are now included. The Angel Tax Credit program has a proven track record of success in assisting promising startups in their early stages of development and is a positive way the Angel Tax Credit is impacting Connecticut's small business community.

Investments in these companies made by angel investors and angel investment networks are eligible to receive a tax credit equal to 25 percent of the amount of the equity investment through the Angel Tax Credit Program.

Connecticut Innovations investment programs spur investment in early-stage businesses with the potential for significant economic impact and job growth. The programs are as simple as they are effective, creating mutually beneficial outcomes for investors, businesses, and Connecticut's economy.

In FY 2021 the legislation was revised to include Social Equity Companies in the Cannabis industry. The Social Equity Council is still going through the application process. The first Social Equity Companies were approved in Fiscal Year 2023. 2 Qualified Cannabis Business's received \$3,080,000 in investments. The Qualified Connecticut Business's have created or retained XXX jobs as of May 31, 2023. The state has invested \$1,232,000 via angel credits awarded, generating a leverage factor on the program of 2.5X. Investments in these Qualified Cannabis Companies that meets the Social Equity Company criteria made by angel investors and angel investment networks are eligible to receive a tax credit equal to 40 percent of the amount of the equity investment through the Angel Tax Credit Cannabis Program.
