

RE: Financial Assistance Annual Report

In accordance with Section 32-47a of the General Statutes of the State of Connecticut, I am pleased to submit the fiscal year 2025 annual financial assistance report for Connecticut Innovations, Incorporated (CI). This report covers information for all new and outstanding financial assistance provided by CI to recipients between July 1, 1990 and June 30, 2025.

CI's job creation or retention requirements call for each recipient of financial assistance to use their best efforts to create jobs and employ Connecticut residents.

Job numbers reported at 6/30/2025 are derived from filings with the Department of Revenue Services (i.e.: UC-5a, UC-2, or other filings). For Companies that did not submit a DOL filing, CI will continue to pursue said DOL filings to validate jobs reported. In addition, CI will also review financial statements, conduct site visits, and use historical data to validate job numbers. Companies that have no jobs are early-stage companies where only contractors are used rather than FTE's.

The economic benefit criteria used in determining which applications are approved are as follows:

- Formation and development of emerging technology companies with high potential to grow and create employment and vendor opportunities in Connecticut.
- Expansion of the level of economic activity and related employment and vendor activity by emerging technology companies in Connecticut.
- Retention of existing jobs in Connecticut.
- Attraction of new high technology businesses and workers to Connecticut.
- Stimulation of university/industry collaborations to foster the development and transfer of new technology to create and expand, as well as to increase, enhance and update the capacity of businesses in Connecticut.
- Leveraging of non-state investment in high tech enterprises in Connecticut.
- Review of the credit risk and compare it to the economic benefit received.
- Review of the financial strength of the recipient.
