III. Update from State- Anthony Anthony

- COT is working with DOT on new highway signs to come into Connecticut with new messaging.
- Just finished a legislative session and the extra \$1,000,000 the governor proposed for the tourism budget did not make it through the legislature.
- They swept all ARPA funding
- We are working with what we have for the upcoming legislative session
- Working on how to make our dollars go farther through agency partnerships as well as other places as we begin to look at what we're going to in the next legislative session.

• We are starting to see the impact of a reduced budget CT. Visit las year got 9.4 million unique hits unfortunately year to date we are down 30% compared to last year.

IV. Update from Tourism Director - Rachel Lenda

- Rachel presented a PowerPoint on what's new
- Ct is now the Pizza capital of the US
- The Oyster initiative we did with the Department of Agriculture and the oyster map has received an unprecedented half a billion impressions
- Our PR has improved and we're up over 100% year to date already
- Tourism created 124,000 jobs and state and local taxes generated 1.2 billion
