

**Minutes of a Meeting of the Board of Directors of the

Welcome

Mr. Nelson called the meeting to order at 10:05 am.

Minutes

Mr. Nelson asked the Board members to review the minutes of the April 22, 2020 meeting as presented. A motion to approve the minutes was made by Mr. Romeo, seconded by Ms. Kelly. The motion carried. Additions to the Agenda

No additions to the Agenda were made

Communications/New Business

Mr. Gaudio reminded Board members that all Board meetings are public and noted that moving forward, emails to the Board may include all email addresses.

Membership Update

Appointed Members

Ms. Green-Kazlauskas reported that nearly every seat of the 63 municipalities had been filled; currently 11 seats are empty. She asked Board members who may know interested people in those municipalities to reach out to her to help fill them and that Ms. Macary would send a list of those still needing representation.

Industry/At-Large Members

Mr. Nelson noted the Board is allowed up to 21 at-large members from tourism-related industries in the District. Board members who have recommendations should send them to Ms. Macary, and those representatives will be voted in November.

By-Laws

Mr. Nelson noted the By-Laws for the District were sent to Board members in advance for their review. Ms. Nelson moved to approve the By-Laws as presented; Mr. Gaudioso seconded. The motion carried.

Financial Report

Ms. Allen, Finance Director at the Waterbury Regional Chamber, administrative partner, reviewed the balance sheet and profit and loss statement. She noted the final net income was 354,030.64. Ms. Gaudioso clarified that the balance was specifically allowed by the state of Connecticut due to the COVID-19 pandemic. Ms. Kelly moved to accept the financial reports as presented; Ms. Falcone seconded. The motion carried.

State Marketing Update

Randy Fiveash and Team

Mr. Fiveash updated the Board regarding the state's position due to the pandemic. He noted the state is in a very difficult position, as 22 states were currently on Connecticut's travel advisory list.

Good to See You, Connecticut

Ms. Bove reviewed the Good to See You, Connecticut, campaign. She noted it had two key objectives: reassuring visitors that Connecticut is open for business –safely, and to inspire those who are ready to explore Connecticut to see what is in their backyard. The campaign includes safety videos, social media marketing, and television advertising.

Marketing Committee

Chair Introductions

Ms. Nelson introduced the co-chairs of the Marketing Committee: John Baroody and Jeff McHugh.

Facebook Update

Ms. Macary reviewed the District's new Facebook page. She noted that in one month, the page went from zero to 723 page likes, 750 followers, and 1200 page views with a reach of 5,451. She noted this growth was all organic and that paid campaigns would begin according to the Marketing Committee's plan.

One-Eleven Update

Ms. Nelson reviewed the current status with the One Eleven marketing agency, noting that Mr. Nelson, Mr. Gaudioso, Mr. Fiveash and Ms. Macary recently met with the agency team to finalize a plan to spend the unused marketing dollars. The agency will provide more information to Mr. Fiveash.

Marketing Agency: Storytellers

Mr. Giaccone introduced the members of the Storytellers team to the Board. He noted that the Storytellers team was ready to support the District and promote tourism in the area. The team also showed two videos to the Board.

Committees – Call for Members

Mr. Nelson noted the need for members for several committees, including the Nominating, Legislative and Marketing committees. He noted that elections for officers would take place at the November board meeting, so a nominating committee would need to be formed. Mr. Gaudioso noted the Marketing Committee is growing, but needs representation from Fairfield County. They asked anyone interested to reach out to Ms. Macary.

Call to Action

Mr. Gaudioso reviewed the action items Board members can take next, including liking and sharing the Facebook page, asking venues to fill out the District's Google form, sharing photos and video for promotion, and joining future partner roundtables.
