## **Instructions for Completing the Notification of Operation Under RCSA §22a-174-33b**

*Use these instructions to complete the Notification of Operation Under RCSA §22a-174-33b form (DEEP# - Notice-of-Op.-22a-174-33b). All applicable regulations should be reviewed prior to completing the notification form. It is the regulated entity's responsibility to comply with all applicable regulations. ### **Introduction**

In accordance with subsection (h)(1) of RCSA §22a-174-33b Limit on Premises-Wide Actual Emissions Below 80% of Title V Source Thresholds, any owner or operator committing to operate a premises pursuant to the section shall submit a notification to the commissioner, on forms provided by the commissioner. These instructions are meant to provide guidance while completing the Notification of Operation Under RCSA §22a-174-33b (DEEP# - Notice-of-Op.-22a-174-33b).

### **Part I: Owner/Operator Information**

**1. Owner/Operator Name** – Provide the legal name, mailing address, business telephone number, contact name, contact title and e-mail address of the owner or operator of the subject premises. If the owner or operator is an entity transacting business in Connecticut and is required to register with the Connecticut Secretary of State, provide the exact name as registered with the Connecticut Secretary of State.

**2. Legal Name of the Agent for Service of Process for Owner, if applicable** - If applicable, provide the legal name and mailing address of the agent for service of process for the owner of the subject premises.

**3. Individual With Primary Managerial Responsibility of the Subject Premises** - Provide the name, mailing address, business telephone number and e-mail address of the individual with primary managerial responsibility for the premises.

### **Part II: Site Information**

**1. Site or Facility Name** - Provide the site or facility name of the premises electing to operate under RCSA §22a-174-33b.

**2. Location of Site or Facility** - Provide the street address, city/town, state and zip code of the premises electing to operate under RCSA §22a-174-33b.

## Part II: Site Information, continued

**3. Previous registration under the General Permit to Limit Potential to EMIT (GPLPE) -** Indicate if the facility was previously registered under the General Permit to Limit Potential to Emit (GPLPE) issued on November 9, 2015. If the facility was registered, provide the previous approval of registration number issued in accordance with the GPLPE in the space provided.

**4. Date upon which the premises will commence operation -** Provide the date upon which the premises will commence operation in accordance with RCSA §22a-174-33b. This date shall be no earlier than November 9, 2020.

*The owner or operator of any premises who satisfies the applicability criteria of subsection (b)(1) of this section shall comply with all conditions and applicable requirements of this section until such time the owner or operator submits a notification to the commissioner, in accordance with subsection (h)(2) of this section, of cessation to operate a premises pursuant to this section (DEEP # - Cease-Op.-22a-174-33b)*

**5. Individual designated by owner/operator to answer questions pertaining to this notification -** Provide the name, business telephone number and e-mail address for the individual designated by the owner or operator to answer questions pertaining to the notification.

## Part III: Consultant or Engineer Information

**1. Engineer(s) or Consultant(s) employed or retained to assist in preparing the notification -** If a consulting firm or engineer was retained for the purpose of preparing this notification on behalf of the owner or operator identified in Part I, provide the name of the firm or engineer, mailing address (street, city/town, state and zip code), business telephone number, contact name, contact telephone number and contact e-mail address. List the services provided.

## Part IV: Certification

The authorized representative for the owner or operator and the individual(s) responsible for actually preparing the notification must sign this part. The notification will be considered incomplete unless all required signatures are provided.

*By signing the notification each individual is certifying that they have read and agree with the following statement:*

*“I have personally examined and am familiar with the information submitted in this document and all attachments thereto, and I certify that based on reasonable investigation, including my inquiry of the individuals responsible for obtaining the information, the submitted information is true, accurate and complete to the best of my knowledge and belief.*

*I understand that any false statement made in the submitted information may be punishable as a criminal offense, under section 22a-175 or 53a-157b of the Connecticut General Statutes.”*

**Sign and date -** The authorized representative shall sign and date the notification form.

**Print or type -** The authorized representative's name and title shall be printed or typed.

**Sign and date -** If an individual other than the authorized representative prepared the notification form the preparer shall also sign and date the notification form.

**Print or type -** If applicable, the preparer's name and title shall be printed or typed.

If additional signatures are required please reproduce the sheet for Part IV: Certification, check the box that additional signatures are required, and attach the signed copies to the notification form.
