#### Connecticut Clean Cities 2021 Strategic Action Plan:

#### 1. Statewide Communications Plan

- Quarterly newsletter with input from all regions of the state
- CT Clean Cities Facebook page with coalition events and stakeholder resources and tools
- Strengthen coordination with state agencies on a statewide approach to alternative fuel solutions
- 2. Expand and improve our current coalitions coverage to the entire state
- 3. Representation of all alternative fuel vehicles, and related infrastructure
- 4. Hold multiple stakeholder meetings to provide resources as well as to receive feedback on how to support stakeholder's alternative fuel and advanced technology goals

- 5. Work with stakeholders to provide statewide input to the Annual Clean Cities Report
- 6. Greater involvement in future state agency programs that relate to the Clean Cities mission
- 7. Provide opportunities, economic relationships, and links to incentives for the deployment of AFVs
- 8. Endeavour to work with neighboring state coalitions and regional coalitions when practicable related to projects or information exchange
- 9. Grassroots support, outreach and education and the boots on the ground to work collaboratively and directly with public and private fleets.

### Municipal EV Readiness Toolkit 12-Week Program

The Municipal EV Readiness Toolkit is a 12-week program that supports the collaboration of departments and towns in their journey to become EV ready. Each participating town plays an essential role in helping Connecticut reach the goal of 125,000 electric vehicles by 2025 and 30% electrification of medium and heavy-duty trucks by 2030.


