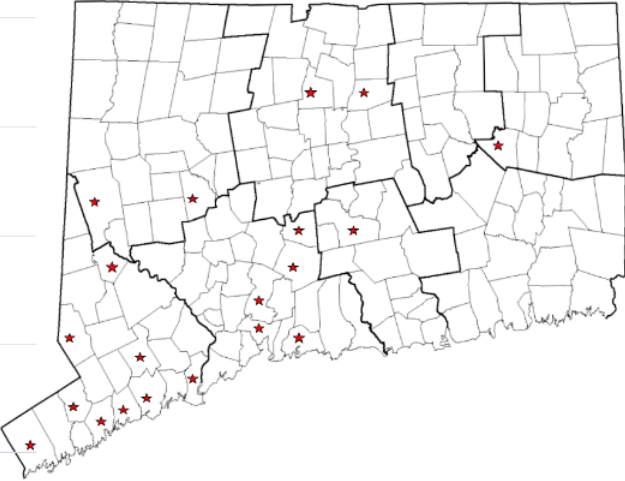
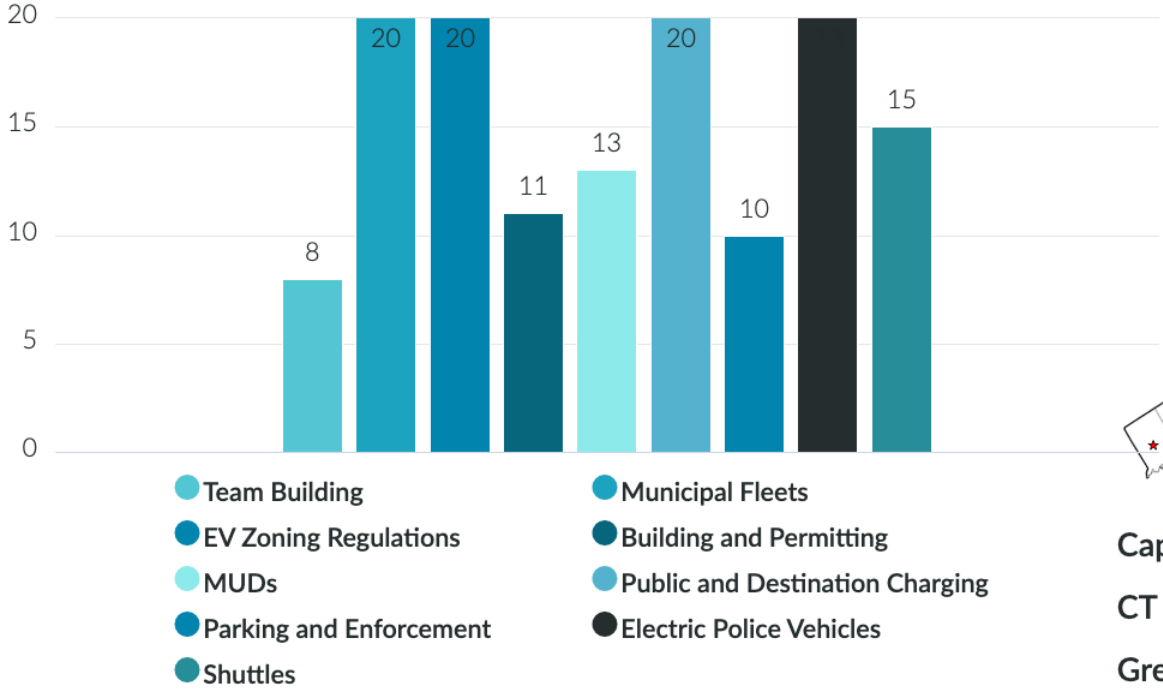
- Paul Wessel was appointed to CHEAPR Board and is looking forward to representing Connecticut's Clean Cities Collective
