

### Community-driven Transportation Plans for the Northeast

- Prime recipient: Northeast Energy Efficiency Partnerships (NEEP).
- Project period: October 2023 to March 2026.
- Project partners: New Hampshire, Vermont, and Connecticut.
- Goal: Comprehensive and collaborative regional clean transportation plan.
- Communities: Bridgeport and Winsted/Winchester.
- Engagement methods: surveys, workshops and forums in collaboration with residents and community organizations.

# COMMUNITY-DRIVEN TRANSPORTATION PLANS FOR THE NORTHEAST

October 2023 - March 2026

- In the 1st Winsted Community Forum, we used the analysis of Winsted survey results to create a list of barriers to EV adoption in the town of Winsted.
- After a community discussion at the last forum, the most notable barriers were identified, specifically for the location of Winsted.
- This forum will find solutions that are actionable and practical for the community. These solutions will combat the previously identified barriers.


