

Notice of Intent to Revise the State Implementation Plan

The Commissioner of the Department of Energy and Environmental Protection (“DEEP”) hereby gives notice of her intent to amend the Clean Air Act State Implementation Plan (“SIP”). The proposed SIP revision will be submitted to the U.S. Environmental Protection Agency (“EPA”) for review and approval. The authority to adopt this SIP revision is granted by Sections 22a-5 and 22a-174 of the Connecticut General Statutes. This notice is required pursuant to Title 40, Code of Federal Regulations (“CFR”), Section 51.102.

DEEP is proposing to submit to EPA a revision to the [SIP](#) to request incorporation of the following case-by-case volatile organic compound Reasonably Available Control Technology (“RACT”) determination:

DEEP intends to issue Consent Order No. 8383 to Algonquin Transmission, LLC, to establish emission standards that are determined to satisfy RACT pursuant to Section 22a-174-32(e)(1)(D) of the Regulations of Connecticut State Agencies for the facility at 252 Shunpike Rd, Cromwell, Middlesex County, CT.
