(If vessel configuration will not permit this location, the HIN shall be placed in plain view on the outside of the vessel as near as possible to this location.) Additionally, the HIN shall be placed in a second but hidden location somewhere on the vessel.

2. Send the completed ORIGINAL form to the Department of Energy and Environmental Protection (DEEP) at the address on the front page of this form.
3. DEEP will send your **hull identification number (HIN)** to you and further instructions to complete the process.

Alternate Process

IMPORTANT: You have the right to obtain a temporary registration while this application is being processed, but this will require that you make one visit to the Department of Motor Vehicles (DMV) **before** sending your HIN application to the DEEP and a second visit to the DMV after DEEP has endorsed and returned your application.

If you wish to obtain a temporary registration that will allow you to operate the vessel while your HIN application is being processed, take the completed ORIGINAL of this form, proof of ownership as required by DMV (consult the DMV website at [www.ct.gov/dmv](http://www.ct.gov/dmv) ) and a completed DMV [Form B-148](#) (available online at [www.ct.gov/dmv](http://www.ct.gov/dmv)) to any DMV office. If you cannot obtain a DMV Form B-148 online, one will be available at the DMV.

DMV will mark your HIN application, scan it, and return it to you. You will be issued a registration number on a temporary registration document but you will not be issued decals at this time.

Once you have been issued your temporary registration:

1. Make a copy of the DMV-marked HIN application for your records.
2. Send the completed ORIGINAL DMV-marked HIN application to the DEEP at the address on the front page of this form.
3. DEEP will send your HIN to you and further instructions to complete the process.
