**Meeting Purpose:** This meeting will open with reflections on this year's legislative session with respect to climate action with the opportunity for questions from attendees. Following that discussion, DEEP will kick off the development of the Comprehensive Climate Action Plan (CCAP) to identify actions to reduce climate pollution while also improving air quality, lowering energy costs, and increasing community resilience. There will be an opportunity for public comment.

### Background on the Connecticut Climate Pollution Reduction Grant Program

In 2023, DEEP was awarded \$3 million in funding from Phase 1 of the EPA Climate Pollution Reduction Grant to update and undertake further [climate action planning](#) to reduce greenhouse gases (GHGs) in Connecticut. EPA required that CPRG grantees produce I) a [Priority Climate Action Plan \(PCAP\)](#) by March 1, 2024, which included a focused list of near-term, high-priority, implementation-ready measures to reduce GHG pollution; and II) a Comprehensive Climate Action Plan (CCAP) to establish near-term and long-term GHG emission reduction goals and strategies for all significant GHG sources and sectors in Connecticut due to EPA by July 1, 2026.

The CCAP will serve as a roadmap for the state to identify and quantify the GHG emissions reduction potential of policies or programs that Connecticut can take to meet the state's

statutory emissions reductions planning targets while also assessing the co-benefits of those measures. Those co-benefits can include the potential to lower energy costs and increase community resilience as well as provide cleaner air, improve public health, create jobs, and other benefits. The CCAP includes an assessment of the benefits of these measures for low income and disadvantaged communities in the state. This plan will prioritize recommended GHG reduction measures that help Connecticut's residents.

## Visitor Parking for 79 Elm Street

1. Enter parking garage from 120 Capitol Avenue and take a ticket upon entry (keep your ticket with you as you will need it before leaving for the day).
2. Exit the garage on foot at the door facing Clinton St, (b/w B1 and Level 1) proceed via (**purple line**) to the 79 Elm St. Lobby entrance facing Bushnell Park.
3. Check in at the 79 Elm St. Security Desk with a valid ID. Your parking ticket will be validated by the Event Coordinator and their team.
4. When leaving the building, (if you received a visitor sticker with Security), check out with Security at 79 Elm St. Lobby.
5. Proceed to the parking garage office (at garage entrance) with your parking ticket, (follow **red line** walking up Clinton St.) The attendant will take the ticket and swipe you out upon retrieving your vehicle or hand you a different ticket that will scan you out of the garage.
