On September 3, 2019, Governor Ned Lamont issued [Executive Order No. 3](#) (E.O. 3) establishing the Governor's Council on Climate Change (GC3) and strengthening Connecticut's commitment to transition to a decarbonized economy and enhance resiliency of the state's economic, cultural, and natural resources to the impacts of climate change.

The Department of Energy and Environmental Protection (DEEP) will hold a public meeting of the GC3 on **July 15, 2020** to review the progress and findings of the GC3 Working Groups and a timeline for the completion of the Work Group and Council reports by the first deadline in the Executive Order 3 of January 15, 2021. **The meeting is open to the public and will include an opportunity to provide public comment.** Individuals may pre-register by 4:00 pm on July 14, 2020 to provide public comments by emailing [deep.climatechange@ct.gov](mailto:deep.climatechange@ct.gov). Written comments may also be submitted by email after the July 15th meeting.
