- Transportation subcommittee was especially successful in integrating EEJ concerns from the top
 - Other subcommittees need to start off with the EEI considerations as well

- Equity, EJ & Adaptation

Dr. Mark Mitchell, George Mason University

- Need for hyperlocal adaptation planning
 - Community members need to lead the development of the adaptation plan

- Need for identification of community groups that have strong grassroots base
- 2 approaches necessary:
 - Tools for the GC3 to engage (e.g., webinar series)
 - Tools for community residents to engage in the GC3 process, and more broadly with climate adaptation planning
- Key feedback to be considered:
 - Community foundations need funding
 - Statewide EJ plan needed, and each community needs its own EJ funding
 - Marianne Engelman-Lado: those recommendations that have a price tag (e.g., mapping tool, hyperlocal toolkit, and support for outreach) should potentially be lifted up in the report
 - Toolkit needed to help locate disability and EJ advocates
 - EJ Consultants/specialists are needed
 - University-based? NGOs?
 - Collecting storytelling, produce reports, take those to policymaking bodies
 - Experts on EJ and housing, EJ and energy, EJ and transportation, etc.

- Mapping Tool

Marianne Engleman Lado, Yale & VT Law School

- Key recommendations:
 - Legislative enactment and financial support
 - Budget number still doesn't exist, may be developed during public comment period
 - Public-private partnership model for development of tool
 - Role for DEEP and DPH in the tool's development, but also space for looping in the existing expertise across the state
- Agreement that there should be an index of relative vulnerability as well as using that index of vulnerability in decision-making as the tool is launched
 - Tool should be made available as a resource for both statewide and local planning and implementation
- Denise Savageau: UCONN CLEAR may be a good resource for the tool and should be looped into this project.
