Eric Hammerling, Executive Director, CFPA

(5 minutes)

Welcome and Introductions: Chair Hammerling welcomes all to the 8th meeting of the Forests Subgroup of the Governor's Council on Climate Change (GC3). The Chair briefly introduces the evening's topic and two expert presenters; Tony Leiserowitz and Mary Tyrrell, followed by a public comment period and Dan Peracchio, DEEP's Forest Planner and lead author for Connecticut's 2020 Forest Action Plan for a progress update.

Chair Hammerling then provides a summary of the Forests Sub-Group work to-date.

- Formed at the end of January 2020
- Reviewed recommendations of CT's 2011 Climate Adaptation Plan.
- Discussed changes in scientific understanding since 2011.
- Looked at models to use as Baselines for Carbon storage/Climate mitigation.
- Addressed forest issues in urban areas such as equity, green infrastructure, air quality, and the many benefits of trees to people.
- Reviewed various forest management approaches to achieve increased carbon storage, sequestration, biodiversity, and forest health.
- Learned about protecting vulnerable human and natural communities.
- Considered developing meaningful forest protection goals and implementing related funding mechanisms.

The Chair makes a point of acknowledging members of the Forests Sub-Group for their time and involvement, encouraging them to maintain their enthusiasm for the final push toward a GC3 draft report and recommendations to be submitted by the end of June. Chair Hammerling reminds all of the online resources from past Forests Subgroup meetings located on CFPA's website at ctwoodlands.org, and DEEP's web pages related to the GC3 and the Forests Sub-Group.

The Chair then conducts a member roll call, reviews proper Zoom etiquette including muting audio, and how the public comment will proceed. Chair Hammerling extends a hearty appreciation to assisting DEEP staff members Chris Martin, Cary Lynch, and Jaimeson Sinclair.

I. Aligning with municipal/regional adaptation efforts

1. Anthony Leiserowitz, Director of the Yale Program in Climate Communication – communicating with the public about forests and climate. Presentation posted on GC3 website. A couple of important hyperlinks; 1) Climate Communication | Yale Climate Opinion Maps (2019) and Yale Climate Connections.

2. Mary Tyrrell - communicating with forest landowners about forests and climate.

II. **Public comments**

Susan Masino, Simsbury, Co-chair GC3 Science & Technology Working Group. Reemphasizes the importance of linking health and climate. Keeping forests as forests is not a clear enough message. We need some forests for resource extraction, some for scientific monitoring, and some to be left alone. Landowners need to get information on a full range of choices. References locally grown wood stamping program in Connecticut.

Chelsea, Trinity College. Took part of public opinion survey of Southern New England forests, what the public wants from forests. Results showed many respondents want to preserve forests with legal protection for old growth forests and protecting against invasive species. Currently there is insufficient protection for forests.

Chris Donnelly, DEEP Urban Forester. Reflects on his parents who grew up during the Great Depression, nothing goes to waste. Times have changed to now more of a consumer mentality with an excess of experts. Self-reliance seems preferred over getting information from experts. Healthy skepticism, towards experts vs experience. How to communicate with the public. Poses the question; What role do we expect from forest landowners with regards to mitigating and adapting to climate change.

III. **Connecticut's Forest Action Plan Update**

1. Dan Peracchio, DEEP Forest Planner – Summary actions to date, preliminary findings, updated timeline and steps to completion. Updated USDA Forest Service submittal deadline from June 2020 to December 31, 2020 due to COVID-19 business disruptions.
