    - Adaptive Capability

Scott Gaul: The CCVI data can help show risk factor, so wouldn't need to guess.

Brenda Bergeron: Assessments can be valuable for telling people what they don't know. Rebecca French: They definitely talked to more than one person in the Massachusetts

survey. Sustainability Officers can be a starting point as well.

Rebecca French: It also may further focus additional planning and implementation efforts I those areas.

Mary-beth Hart: Can help agencies get out of the reactive, post-storm mentality Denise Savageau:

- Coastal erosion vs coastal inundation
- Differentiation between chronic vs acute events is something that should be considered

Rebecca French: How much we can automate this process? Is there away to have the program pop out a list of buildings with high vulnerability?

John Truscinski: Still need an on the ground evaluation to see what is really gong on.

David Murphy: See Resilient Connecticut Phase II report CIRCA posted for an example.

Wayne Cobleigh: Connecticut Green Buildings has a similar kind of database.

### **State Agency Engagement**

Rebecca French: What additional agencies should we do a closer discussion with that are not already on GC3?

- Connecticut Airport Authority, Military, Quasi organizations, DDS, Mental Health and Addiction Services, Veterans Administration

Rebecca: If we're managing a building and the occupants of a building is that included in the state's real property

Scott Gaul: The state does own property that has occupants. Can use state list of real property to include buildings with inhabitants.

Rebecca French: We can put that in the preamble of the survey.
