**Welcome and Introduction of Co-chairs:** Kristin Barendregt-Ludwig, Lee Cruz, Maisa Tisdale

- Co-chairs introduce themselves, their work affiliation, and their prior experience working with GC3
- Ashley Benitez facilitates the introduction of working group members
- Working group members state their name and professional affiliations

#### **Charge to the EEJ Working Group:** Rebecca French, Director, Office of Climate Planning

- Executive Order 21-3 was signed in December of 2021 and advanced additional initiatives and expanded the duration of GC3
  - Established CEEJAC to advise the Commissioner of DEEP on current and historic environmental injustices as well as health disparities and racial inequities
- For 2022, working groups are charged with engagement, implementation, and monitoring and evaluating programs
- Each working group has an Equity and Environmental Justice liaison to provide expertise in this area
- The EEJ working group will review and apply the GC3 2020 equity lens to all working group findings
- Timeline review:
  - Each group will meet with the Equity and Environmental Justice working group in November
  - o In December, working groups will present their findings
- There are two subheadings for the GC3: Mitigation and Resiliency and each working group operates under those umbrellas
- Working groups should include cross-cutting themes in mind

- Utilize equity lens
- o Align with municipal and regional climate mitigation and adaptation efforts
- o Be informed by science
- Leverage new and expanded state and federal climate programs (significant shift in the landscape since 2020)

#### Review of 2020 EEJ Work Products: Lee Cruz

- Presents the definition of "equity"
- Discusses the various types of equity: distributive, procedural, contextual, and corrective
- Presents key principles that apply to GC3 process
- Presents GC3 Public Participation Checklist developed during previous GC3 processes
  - o Includes guiding questions for accountability and community involvement
  - o Developed chart that provides guidance for remote engagement
- Presents 2020 Recommendations and their status
  - o Community engagement strategy for climate planning
  - o Environmental justice and climate vulnerability mapping tool
  - o Prioritize mitigation in vulnerable communities
  - Community Resilience Program
  - o All recommendations are currently in progress
- Presentation of webinar series hosted in 2020

Questions and Discussion: For full comments please see the Zoom recording and/or audio transcript

- Max Teirstein: Will IRA funding support GC3 initiatives? Understands that a big charge of the working group is around monitoring, which could be supported through funding.
  - Rebecca French: Still determining how the bill applies to recommendations from the GC3. We know more about the Infrastructure Investment and Jobs Act since it has been out longer.
- Kathy Fay: Sometimes DEEP needs to solicit public input from communities and she is concerned around time frames, which can be too tight to solicit input. Is there a policy in place about how much lead time we should give communities?
- Denise Savageau: There is a role for the EEJ working group to be more proactive.
   The 2022 timeline is shorter but looking at 2023 gives us the opportunity to think about how we bring folks in and give people a chance to participate
  - Lee Cruz: Agrees that we should be looking at how we can reconvene people: lead-time, childcare, other initiatives allow people to participate more readily
- Diane Lauricella: Notes budgeting process for towns is beginning and we should try to ensure that municipalities are connected to federal and state funding
  - Rebecca French: Do have representatives from municipal and regional governments on the working groups, so we have people to reach out to and connect with

#### **Discussion of November Meetings:** Ashley Benitez Ou

- Reiterates charge for the 2022 working groups
- Highlights that the EEJ working group will ensure all recommendations are viewed through the equity lens described in the Jan. 2021 GC3 report
- Presents November working group meeting schedules
  - Notes that we are soliciting working group recommendations for meeting agendas
  - o Group will also provide written comments following the meetings
- Ashley Benitez Oz: What recommendations do you have to administer the EEJ process?
  - Alexander Rodriguez: Appreciated the comments about various kinds of equity. Sees his role as grounding the group in those who are most vulnerable and notes that part of what he envisions is asking the working groups how their recommendations can uplift communities that need to be connected to resources.
  - Lee Cruz: Agrees with Alex's ideas and notes that the other working groups need someone to remind them of the equity charge.
  - Kristin Barendregt-Ludwig: Also notes that EEJ members can connect other working groups with the tools EEJ has already developed
  - Denise Savageau: Agrees that priority should be on training other working group members and giving them the tools they need. Should another checklist be created that includes broad impacts that touch on environmental justice, like job creation?
  - o Kathy Fay: Likes Alex's suggestion to ensure inclusion of all communities and appreciates Denise's suggestion of a more comprehensive checklist.
  - Edith Pestana: Highlights how important it is for EEJ working group members to have a shared understanding what designates a "vulnerable" community.
  - Maisa Tisdale: When we give checklists, we should also give measures, which should be considered alongside the checklist suggestion.
- Rebecca French: Are working group members interested in participating at the federal process?
  - Alex Rodriguez: Yes, if there is any way to relate what is occurring federally to boosting public participation at the state and local level, including providing funding to allow participation, that would be ideal.
  - Denise Savageau: Because programs function at the local level, federal
    participation and comments are critical and we should be better at this. Also
    notes that we tend to use the EPA definition of equity, which doesn't come
    from a benefit standpoint, so while we should consider preventing harm, we
    should also consider providing benefits, as well.

### **Looking Ahead to 2023:**

• Ashley Benitez Ou: What activities would the group like to see in 2023?

 Rebecca French: Agrees that the checklist idea is great and could be shifted to 2023

Alex Rodriguez: Goal is to uplift populations that are most marginalized and affected by climate harms and racial inequities. There is good momentum at the state and federal level but there was an effort to push forth dirty permitting reform, which is the opposite of environmental justice. Alex hopes that this iteration of the GC3 uplifts communities, holds polluters accountable, and considers levying fees on fossil fuel companies that hinder climate action in Connecticut.

Joanna Wozniak-Brown: There was a comment on the Inflation Reduction Act and other things rolling out on the federal register on how those projects should be rolled out. Are there components of policies that can result in achieving equitable program rollout?

- "(B) mitigating climate and health risks from urban heat islands, extreme heat, wood heater emissions, and wildfire events;
- "(C) climate resiliency and adaptation;
- "(D) reducing indoor toxics and indoor air pollution; or
- "(E) facilitating engagement of disadvantaged communities in State and Federal advisory groups, workshops, rulemakings, and other public processes.
