

NOTICE OF PETITION FOR DECLARATORY RULING

Pursuant to Section 22a-3a-4(a)(4) of the Regulations of Connecticut State Agencies, the Commissioner of Energy and Environmental Protection hereby provides notice that on February 21, 2023, Ranald K. and Robin L. Nicholas (collectively "Petitioners"), filed a petition for declaratory ruling ("Petition") with the Commissioner. The Petitions request the Commissioner issue a ruling that SR Litchfield, LLC be required to obtain an individual permit – rather than registration under the General Permit for the Discharge of Stormwater and Dewatering Wastewaters from Construction Activities - for construction of a 55,000 photovoltaic solar power project in Torrington.

The Commissioner is also providing notice of this matter to additional persons or entities that may have an interest in this matter. Such persons or entities are noted below.

Dykes, signed by the commenter or his/her attorney or other representative, contain the name and telephone number of the commenter and his/her attorney or other representative. Pursuant to Conn. Gen. Stat. § 176(e) and Regulations of Connecticut State Agencies § 22a-3a-4(c)(3), on or before April 24, 2023, the Commissioner shall "(1) [i]ssue a ruling declaring the validity of a regulation or the applicability of the provision of the general statutes, the regulation, or the final decision in question to the specified circumstances, (2) order the matter set for specified proceedings, (3) agree to issue a declaratory ruling by a specified date, (4) decide not to issue a declaratory ruling and initiate regulation-making proceedings, under section 4-168, on the subject, or (5) decide not to issue a declaratory ruling, stating the reasons for its action."
