Dear Attorney Cuoco:

The Department of Energy and Environmental Protection (DEEP) and the Public Utilities Regulatory Authority (PURA) acknowledge receipt of your request for an extension of time dated August 22, 2017 to respond to the data requests issued by DEEP and PURA on August 16, 2017 in the above referenced joint proceedings. In that request, Dominion Energy Services, Inc. (Dominion) seeks a three week extension of time to respond to such data requests.

As indicated in its data requests, the information sought by DEEP and PURA is necessary to model the most accurate going forward costs of Millstone units two and three in order to assess the economic viability of the units in accordance with Executive Order Number 59 issued by Governor Malloy on July 25, 2017 (Executive Order). Without this information, DEEP and PURA, with input from their consultant, would need to estimate the going forward costs based on the best available public information.

DEEP and PURA hereby grants Dominion's request for a three week extension of time, until September 19, 2017, to respond to such data requests. Because DEEP and PURA are working under a tight timeframe established by the Executive Order on this urgent topic, Dominion's request is granted with the expectation that Dominion will submit information to DEEP and PURA on a rolling basis during the period leading up to

the September 19, 2017 deadline, as such information becomes available. The timely submission of information will better enable DEEP and PURA staff to conduct the critical analysis required by the Executive Order in a prudent, efficient, and cost effective manner.
