Dear Attorney Cuoco:

The Department of Energy and Environmental Protection (DEEP) and the Public Utilities Regulatory Authority (PURA) acknowledge receipt of a motion for protection filed by Dominion Nuclear Energy Connecticut Inc. (Dominion) on November 30, 2017 in the above captioned docket. In that motion, Dominion requests protected treatment for a two-page filing containing "certain commercial and financial information," specifically "confidential and proprietary financial data and calculations regarding the Millstone Power Station in Waterford, Connecticut." Motion at 1.

DEEP and PURA find that the two-page document contains high level, financially sensitive data and calculations relating to cost and revenue projections of the Millstone Power Station. DEEP and PURA find that this information constitutes commercial or financial information given in confidence, not required by statute. DEEP and PURA also find that (1) this information has some degree of independent economic value from not being generally known to or obtainable by other persons who can obtain economic value from the information's disclosure or use, and (2) it is reasonable under the circumstances to maintain its secrecy. As such, DEEP and PURA find that the information contained in the two-page filing is eligible for protection pursuant to Sections 1-210(b)(5)(A) and 1-

210(b)(5)(B) of the Connecticut General Statutes. DEEP and PURA hereby grant Dominion's motion for protected treatment.
