#### **LIEAB Update – Carlene Taylor, DSS**

The current application process in largely online and mail in. This virtual process has resulted in large numbers of applications being rejected. Two Agencies still are doing in person applications however across the board COVID-19 is still causing delays in processing applications. Applications have up to 10 days after the postmarked date to be processed before being denied. DSS then continued to review the program statistics based on the handout provided to the board members. Heating season is expected to start November 2<sup>nd</sup> this year. Do not know what the funding level will be this year. Funding is expected to be the same as last year.

Wendy Wanchak-

Q: Did the SSI increase result in more denials based upon income verification?

A: Don't know if agencies are tracking income changes based solely on SSI

Q: If the applicant only has SSI as income and no information has changed can they be fast tracked through the application process?

A: Current process would have to be changes and if it was a significant process change it would potentially delay the delivery of program services for 2020-2021

Gannon Long-

Q: How is outreach being done to get people who have been denied services the services they deserve after the application was failed?

A: The agencies are actively participating in outreach efforts to work with clients to get the information required or make corrections to the application necessary to allow them to receive services

Brenda Watson-

Q: Are water heaters eligible for replacement?

A: We are including water heaters as part of the program this year.
