#### Updated Policy, Procedure and Measures When Using the Weatherization Assistant 8.9 Audit Tool

The purpose of this guidance is to instruct agencies of updated changes in policy regarding CT WAP requirements for performing site-specific Energy Audits using the Weatherization Assistant 8.9 (NEAT, MHEA) software.

This guidance pertains to all CT WAP Weatherization programs effective 7/1/2022, unless specified otherwise.

Example: CT WAP Guidance No. 47 Approved Audit Tool Setup Libraries- Fuel Costs (Effective 7/1/2022)

Due to directives issued by the US Department of Energy related to CT WAP's authorized use of the Weatherization Assistant software, CT WAP is providing updated policy and procedure to all subgrantees effective immediately upon receipt.

CT WAP will distribute updated Setup Library Fuel costs to Subgrantees at the beginning of the 2022 program Year. All Subgrantees are instructed to install approved Setup libraries and Fuel costs and utilize the Fuel Costs referenced as Approved CT WAP 7/1/2022.

The comment section will indicate effective date of 7/1/2022 and reference the US Energy Information Administration as the source of the document.

Going forward all Energy Audits run through the NEAT and MHEA audit tools are to utilize the 7/1/2022 setup library with no exceptions, until further notice.

CT WAP requires that all Subgrantees install and provide documentation of successful installation to the Grantee prior to issuing any work orders.

CT WAP Technical will review and approve the use of the updated Setup libraries and authorize resumption of production documents upon receipt of Subgrantee documentation.

CT WAP recommends that all Subgrantee staff and management reference the Weatherization Assistant Users Manual Version 8.9 dated January 2015, Chapter 14, Section 14.3 Fuel Costs, for additional information and also the CT Weatherization Operations and Training Manual Sections 302.7 Audit Software and 302.11(A) Updated Setup Libraries for further details.

# Mobile/Manufactured Home Energy Audit Conditions

As per DOE's Conditional Approval of CT WAP use of the Weatherization Assistant Energy Audit Tool, suspension of all MHEA generated work orders has been suspended until further notice.

Local agencies are directed to complete Mobile and Manufactured Home Energy Audits in the order in which requests are received and forward all documentation, notes, pictures and diagnostic reports, to CT WAP for review and submittal to DOE for evaluation.

MHEA clients are to be advised that some delays may be experienced as a result of this requirement imposed by DOE to evaluate the Mobile and Manufactured Home Audit competency in CT.

U.S. DOE, as a condition of the audit tool approval process, is requiring, at minimum, that the next eight (8) completed MHEA audits be submitted to DOE for approval prior to issuance of any work orders. Upon receipt of each completed MHEA audit, to include all documentation, notes, photos, and diagnostic reports, CT WAP will submit each package to DOE for review. DOE has ensured CT WAP that the review process will be expedited to reduce delays in project completion.
