



**Weatherization Guidance No. 51**

**Effective Date: 7/1/2021**

**Updated Policy and Procedure Regarding Updated Specifications for HVAC Procurements**

The purpose of this guidance is to instruct agencies of updated changes in policy regarding CT WAP requirements for procuring HVAC Measures aligned with DOE WAP Program Year 2021, the 2021 CT Weatherization Assistance Plan (CT WAP) and the DOE approved 2020 Standard Work Specifications (This guidance pertains to all CT WAP Weatherization programs).
