NOTICE OF OPPORTUNITY FOR PUBLIC COMMENTS

Pursuant to Part 440 of Title 10 of the Code of Federal Regulations the Department of Energy and Environmental Protection (DEEP) is in the process of updating the state's Program Year 2024 Plan for administering a 1-4 unit Weatherization Assistance Program (WAP) for Low Income Persons (proposed WAP State Plan) and is providing opportunity for public comment. An additional Notice will be filed with the Secretary of State by April 18, 2024 to notice public hearings to be held on April 29, 2024 and to provide an additional written comment opportunity on a second draft of the proposed WAP State Plan.

All Comments on the first draft CT WAP State Plan are encouraged. DEEP also Specifically invites responses to the following questions:

- 1) How long (how many years) should the Connecticut Weatherization Assistance Program's rent protections be required? (Current Connecticut Weatherization Assistance Program rent protections are as follows: "Landlords shall affirm by signed Weatherization Agreement that they shall not increase the rent paid by eligible tenants of a rental unit that has received weatherization services for a period of two years from the date the weatherization work is completed unless the landlord/property owner can document that the increase is due to factors other than the weatherization assistance performed. In compliance with 10 C.F.R. §§ 440.22(b)(3) and 440.22(e), tenants sign and receive a copy of the agreement, and therefore are aware of the conditions placed on the landlord. Landlords will also agree to charge the same rent to all successor tenants up to the two--year period covered by the Weatherization Agreement.").
- 2) Should fuel switching be permitted as part of the services provided by the Connecticut Weatherization Assistance Program? If yes, why and how could DEEP mitigate potential negative impacts to energy assistance received by the income eligible household?
- 3) Should the Connecticut Weatherization Assistance Program fund the installation of Heat Pumps and Heat Pump Water Heaters when the savings-to-investment ratio is greater than 1.0? Why?
