HISTORY

- Created in response to 21% open space goal in statute (1997)
- 1st round in 1998 and generally offered once a year
- Prior to this program there were State funds for open space conservation, but not consistent
- Funding- State bond money & Community Investment Act money
- Since 1998 \$157 million+ to protect over 42,000 acres



PROGRAM OVERVIEW

- •Grant funds for permanent interests in land (fee acquisition or conservation easements)
- Permanent conservation
 easement granted in favor of
 DEEP w/ commitment for
 passive recreation
- Eligible entities
 - Municipalities
 - Non-profit conservation organizations (land trusts)
 - Water companies



PROTECTION PRIORITIES



- Recreation, forestry, fishing, conservation of wildlife or natural resources
- Water quality of the state's lakes, rivers and coastal waters
- •Land which is eligible to be classified as Class I land or Class II land after acquisition
- Local agricultural heritage
- Equitable geographic distribution of the grants
- Proximity of a property to urban areas or to areas with open space deficiencies and underserved populations

RANKING SCORE CRITERIA

Administrative

- Mapping
- Title, funding, and feasibility within timeline
- Alignment with local, State and regional conservation goals
- Support letters

Public Access & Outdoor Recreation

- Accessibility
- Public outreach
- Trail or greenway connectivity
- Past grant compliance

Environmental Justice & Equity

- Alignment with GC3 EJ recommendations
- Community impact/public transportation
- Population density
- Affordable housing

Climate Change & Natural Resources

- Forests
- Wetlands
- Rivers & Fisheries
- Agriculture & Soils
- Wildlife



APPRAISALS

OSWA Grant Application REQUIRES:

- •1 yellow book appraisal completed appraisals cannot be more than a year old
- •1 appraisal review confirming that the appraisal is yellow book compliant



MAXIMUM GRANT AMOUNT

to a	for	in an amount not to exceed*
Municipality	Open space	65% of fair market value
Municipality	Class I & Class II Water supply property	65% of fair market value
Distressed municipality or targeted investment community **	Open space	75% of fair market value
Distressed municipality or targeted investment community **	Resource enhancement or protection	50% of cost of such work
Nonprofit land conservation organization	Open space or watershed protection	65% of fair market value
Nonprofit land conservation organization (if land is located within a distressed or targeted community)	Open space or watershed protection	75% of fair market value
Water company	Class I & Class II water supply property	65% of fair market value

KNOWN EXISTING BARRIERS

- •Small, isolated parcels did not score as high in criteria
- Length of time
- Complicated process/Need for expertise
- No contamination allowed
- High due diligence costs
- •Environmental Justice Communities don't all qualify for increased funding amounts
- Protection projects done by non-profits in distressed, targeted, EJ communities need permission from Municipal CEO
- •Funding cannot be used for traditional urban parks with infrastructure
- Review board without EJ representation


UPDATES & IMPROVEMENTS

- Application & Scoresheet 2020 additions of EJ specific sections
- Current statute changes SB11
- · Add EJ communities to areas that qualify for 75% FMV
- Allow due diligence costs to be covered by grant money in EJ communities, distressed municipalities and targeted investment communities
- Add two positions to the review board focused on environmental justice and equity
- Align, simplify and clarify application & scoresheet
- Change appraisal requirements
- Future statute changes
- Establish new grant program to cover other park needs
- Additional Outreach
- Partnerships to cover additional costs
- Remediation funding
- · Planning & grant-writing assistance
- Due diligence costs


