## Commercial Fishery Possession and Landing Limits Effective: March 22, 2026

<b>American Lobster</b>	<b>OPEN</b>		Lobster Pot Allocation required to take lobsters by pot. During the closed Season: Sep 8-Nov 28, both dates inclusive, possession of lobster taken from Long Island Sound (LMA 6) is prohibited. Minimum size: 3 3/8"
<b>American shad</b>	<b>CLOSED</b> Opens 4/1		Open: April 1– June 15, except weekends. American Shad may be taken in the Connecticut River only. Maximum gillnet soak time = 4 hours
<b>Atlantic menhaden</b>	<b>OPEN</b>	12,000lb <sup>1</sup> 120,000 <sup>2</sup>	<sup>1</sup> Call-in required when in possession of more than 6,000 lb. Encon Police: 860-424-3503 <sup>2</sup> Taken from outside of CT waters. <sup>3</sup> The directed fishery is closed. The incidental fishery remains open with a 6,000-pound possession limit.
<b>Black Sea Bass</b>	<b>OPEN</b>	2,500lb <sup>1</sup> bi-weekly 60lb <sup>2</sup>  Bi-weekly periods: 3/8-3/21, 3/22-4/4, 4/5-4/18, 4/19-4/30	<sup>1</sup> Black Sea Bass License Endorsement required to take sea bass – INCLUDING from lobster traps. <sup>2</sup> Possession limit for the commercial harvest of black sea bass caught in lobster traps and when in possession of lobsters, no license endorsement required. Does not apply to personal use lobster license holders. <u>Call-in required for landings from lobster pots</u> : provide name, plate number, reporting week ending date and total pounds landed from pots during the reporting week: 860-447-4323. <b>Tautog*</b>	<b>CLOSED</b> Opens 4/1	10 fish <sup>1,3</sup> 3 fish <sup>2,3</sup>	<sup>1</sup> When fishing under a Limited Access Commercial Fishing License (non-creel limited). <sup>2</sup> When fishing under a Restricted Commercial Fishing or a creel-limited license. <sup>3</sup> All commercially harvested Tautog must be tagged with the current year tags provided by the department. <b>Winter flounder</b>	<b>CLOSED</b> Reopens 4/15	50lb or 38 fish	State waters closed to harvest March 1 through April 14. Federally permitted vessels are permitted to land the higher federal limits of fish taken from federal waters. Minimum Size: 12"
<b>Weakfish</b>	<b>OPEN</b>	100lb	Minimum size: 16"
<b>Whelk</b>	<b>OPEN</b>		<b>Effective: January 1, 2026, the Minimum size: 5 1/4" shell length or 2 1/8" shell height.</b>


All the possession limits listed above apply to the aggregate of all persons on board the vessel per trip or per day whichever is the longer period of time. Transfer of these species between vessels at sea is prohibited. In any instance where there is a violation of the possession limit on board a vessel carrying more than one person when the catch is commingled, the violation shall be deemed to have been committed by the owner of the vessel, or the operator of the vessel, if the owner is not on board. **When any person on a vessel is commercial fishing, the commercial possession limit applies to the entire vessel and no person on that vessel may also possess fish under a recreational creel limit.**




### 2026 Weekly Black Sea Bass Landings for Quota Monitoring




### 2026 Weekly Bluefish Landings for Quota Monitoring
