Commercial Fishery Black Sea Bass Winter I Closure

NOTICE

Effective 0001 hours, Tuesday, April 26, 2022, the Winter I commercial black sea bass fishery will be closed through April 30, 2022. Vessels which have sailed prior to 0001 hours, Tuesday, April 26, 2022, and have not yet landed the biweekly limit of 5,000 lbs previously in place for the period that began at 0001 hours on Sunday, April 24, 2022, will be allowed to complete their trip and offload, subject to the previous 5,000 lb landing limit for the period April 24 – April 30 and provided such offload occurs no later than 2359 Saturday April 30.

As of Monday, April 25, 2022, 32% of the 2022 commercial black sea bass quota has been landed. The 2022 Winter I (January 1 through April 30, 2022) cumulative landings target for the commercial fishery is 25% of the quota. The Department was unable to implement a closure at the 25% Winter 1 target or provide more advanced notice of the closure implemented via this notice due to an unanticipated rapid escalation in landing rates.

The Department monitors landings and adjusts trip limits according to Department regulations in an attempt to provide fishing opportunity throughout the year for all participants in the commercial fishery. In addition, the Department strives to provide advance notification of trip limit changes, although this may not always be possible due to rapidly escalating or unanticipated landings. In such circumstances, only a short notification period may be possible.
