



## **Notice to Commercial Fishermen**

### **COMMERCIAL FISHING LICENSE RENEWAL DEADLINE REMINDER**

Public Act 15-52, which went into effect on January 1, 2016, **requires commercial limited access (moratorium) licenses to be renewed annually by March 31<sup>st</sup>**. License applications **MUST BE RECEIVED OR POSTMARKED BY MARCH 31<sup>st</sup>**. The law also **requires a Commercial Fishing Vessel Permit to be purchased annually** for the primary vessel identified on a limited access (moratorium) license for the license **to remain eligible** for renewal in the future. **Quota Managed Species Endorsements**– for fluke, scup, black sea bass and hand harvest of horseshoe crabs – also **require annual renewal by March 31<sup>st</sup>**. The fee is \$15 per species.
