Commercial Summer Flounder and Black Sea Bass Fishery Possession Limit Increases

NOTICE

Effective 0001 hours, Sunday, November 16, 2025, the following possession limits will be in effect for Connecticut's commercial fisheries:

Summer Flounder:

400 pounds – Summer Flounder License Endorsement required.

As of Wednesday, November 12, 2025, the Department estimates that 82.5% of Connecticut's 2025 commercial summer flounder quota had been landed.

Black Sea Bass:

- 3,000 pounds Black Sea Bass License Endorsement required.
- 60 pounds from lobster pots, when in possession of lobsters. No Black Sea Bass License Endorsement required. This does not apply to personal use lobster license holders. Call-in required.
 Harvest of American Lobsters from LMA 6 is prohibited Sept. 8-Nov 28, both days inclusive.

As of Wednesday, November 12, 2024, the Department estimates that 55.7% of Connecticut's 2025 commercial black sea bass quota has been landed.

Please Note, Old Lyme Marine Headquarters will be closed Friday, November 28, 2025.

Federally-permitted seafood dealers are reminded they must submit all reports for a reporting week (Sunday to Saturday) by midnight of the following Tuesday:

The Department monitors landings and adjusts trip limits according to Department regulations in an attempt to provide fishing opportunity throughout the year for all participants in the commercial fishery. In addition, the Department strives to provide advance notification of trip limit changes, although this may not always be possible due to rapidly escalating or unanticipated landings. In such circumstances, only a short notification period may be possible.
