Fire Statistics

In 2022, we recorded 544 wildfires for 473.05 cumulative acres for <u>Connecticut's Wildfire Statistics</u>. As of June 22nd, we've recorded 145 wildfires for 205.05 cumulative acres. Unfortunately, we are not capturing accurate statistics for what is happening across Connecticut. *We need your help!*

Receiving detailed and accurate data reported by your department's dispatch helps us capture accurate statistics and is critical in securing federal funding to provide services to assist your towns. Notifications for ongoing fires can be called in to DEEP Emergency Dispatch at 860-424-3333. Notifications for fires that have already passed can be emailed to <u>deep.forestry@ct.gov</u>. Wildfires can be entered at any time into our Wildfire Reporting App (see below) to help us capture these important statistics. Wildfire Reporting App

In 2020, the Forest Protection Program staff created a Wildfire Reporting App for fire departments in order to help with gathering information and improving communication. Entering data takes 2-3 minutes and can be done easily from a phone or computer. District Fire Wardens can help improve fire statistic reporting immensely by distributing this program to fire departments and helping them learn the application. The Connecticut Rural Fire Council meets twice a year to provide guidance to the Forestry Division's fire program and to identify issues and work towards solutions for rural fire needs. There is one representative for each county. *We are currently looking for replacement council members for Hartford County and Fairfield County*. Suppression

Wildland fire suppression assistance is available to local fire departments. Services available include on-scene technical advice, manpower, and equipment. If you need help with an on-going fire, please contact or have your Dispatch contact the **Department of Energy and Environmental Protection 24-hour dispatch center at** (860) 424-3333.

Hose Exchange

Dirty, 1.5-inch Forestry hose used on a brush fire can be exchanged **at your station** for clean, pressure tested hose, on a length per length basis, in bags of 300'. Include the hose bags when swapping. To schedule a hose exchange, call your Fire Control Officer, or the Department of Energy and Environmental Protection 24-hour dispatch center at (860) 424-3333. Volunteer Fire Assistance

Open to fire departments in *towns* of 10,000 people or less based on the latest census report, the Volunteer Fire Assistance Grant Program aims to improve the capability and effectiveness of Connecticut's rural volunteer fire departments by providing grants to organize, train and equip local firefighters. In 2022, 42 fire departments were awarded small grants, totaling \$96,137.45. VFA funds were used to purchase supplies for Volunteer Fire Departments, including the two portable pumps and five leaf blowers awarded based on the annual Introductory and Refresher Wildfire Training. Additionally, every year a portion of VFA grant funds are used to provide scholarships for cadets. In 2023, scholarships will be awarded for both the Introduction to the Fire Service (ITTFS) class, as well as the ITTFS Advanced Skills and Concepts class. The 2023 Volunteer Fire Assistance grant program was announced via email to departments who provided the Forest Protection Program with a contact email. In the absence of an email, applications were mailed via the US Postal Service. The 2023 VFA application deadline is August 16, 2023.

Introductory Wildfire Training

February 23, 2023 – This 3-hour training covers wildland fire suppression, including an overview of the programs and services offered by DEEP Forest Protection Program, an introduction to fire behavior basics and fuels, suppression methods, fireline safety and hazards. The training was held virtually and administered to more than 600 firefighters. The recording can be accessed via this URL: <u>https://youtu.be/ycmTzrfbyT0</u>

If you have a fire department member you want to share this with or a member who needs to maintain qualification as a "registered" firefighter in their department for fire bill reimbursement purposes, after watching this video, they can have the Chief or training officer submit their name and completion date to <u>deep.forestry@ct.gov</u> to be qualified. A certificate will then be sent to the participating fire department, and DEEP records will be updated. A "registered" qualification is good for three years.

The recipient departments of the leaf blowers from the 2023 Introductory Training are: Dayville Fire Co.; Windsor Volunteer Fire Dept.; Litchfield Fire Co.; Tunxis Hose Company No.1; Riverside Fire Co.. The recipient departments of the pumps are: Broad Brook Volunteer Fire Dept.; Moosup Fire Dept. Congratulations to the recipients!

Fire Warden Program

The Forestry Division has a statutory responsibility to reimburse Fire Departments for expenses associated with forest fire suppression. The <u>District Forest Fire Wardens</u> that serve the state have a primary responsibility of handling fire bills. If you want to submit a bill for <u>Wildland Fire Reimbursements</u> the bills must go through your local Fire Warden within 30 days of a fire. Dry Hydrant Program

During our last Dry Hydrant Program grant round in 2020, we funded eight hydrants in four communities. The next round of the Dry Hydrant Program is scheduled to be announced in Summer of 2023.


Helene's Message

Wildfire Reporting App Field Descriptions

Fields with * are *required*, other fields are *highly* recommended to be entered.

- * Fire Discovery Date: Date fire was discovered, dispatched date
- * **Fire Discovery Time:** Time fire was discovered by either civilian calling 911, or firefighter locating fire.
- **Street Address Closest to Fire:** Physical address of fire, or street of best access to fire.
- **Town where Fire Occurred:** Drop down box, Select town. If fire is in multiple towns, select first department town that was dispatched.

Ownership: Click on circle next to owner of property the fire origin is on.

Geographical Map for Computer: Click blue icon if it isn't already placed on the location of fire.

Use +/- boxes to zoom in/out

Geographical Map for Cell Phones: Tap on map, this will give you access to using map functions.

Enter address in white address bar under the burgundy title bar or click use current location in drop down of address bar. Click Allow to gain access to location. If needed, Zoom using the +/- buttons on left side of screen or use fingers. Once location is found and the blue marker is at the proper place on the map, hit the back arrow on the top left. This will bring you back to the form.

Cause of Fire: Drop down box, select Cause.

Any Residences Threatened by this fire?: If no action was taken on this fire, could it have burned the residence down?

If Yes, additional question is asked. How many? Type in #.

Are Any Residences Lost by this fire?: Were any residences burned or destroyed in this fire?

If Yes, additional question is asked. How many? Type in #.

Are other Structures threatened by this fire?: If no action was taken on this fire, could it have burned any Sheds, Garages, Outbuildings, etc.?

If Yes, additional question is asked. How many? Type in #.

Are other buildings lost by this fire?: Were any sheds, garages, outbuildings etc., burned or destroyed in this fire?

If Yes, additional question is asked. How many? Type in #.

Firefighter Injury (s) in this fire?: Was any firefighters hurt during any stage of fire?

If Yes, additional questions are asked:

Please Describe the Injury(s): Type in what the injury that occurred was.

How many injury(s): type in #.

Number of Fatalities: Type in # of firefighter fatalities. Type 0 if none occurred.

Fire Containment Date: Date of which the fire had no heat or smokes. This may be entered in at a later date due to fire occurring for multiple days.

Fire Containment Time: Time of which the decision was made that the fire was completely out.

- **Final Acreage of Fire:** Type in # of acres if unknown type in your estimated size to the nearest .10 of an acre.
- **Name of Submitter:** Type name of person filling out report, or chief of department. This contact information can be used if the Forest Protection Officers need to make contact about the fire or hose exchange.
- **Phone number of Submitter:** Type in ###-### format, the best phone number to use for the Forest Protection Officers to make contact.

Once Form is completed, hit **Submit**. Please note, it may take up a few days to get a reply if you need a hose exchange or if a Forest Protection Officer needs to contact you about the fire. <u>For immediate assistance, call the</u> <u>DEEP</u> <u>Dispatch at 860-424-3333.</u>

ENFORCEMENT OF OPEN BURNING IN CONNECTICUT

Open Burning laws of the state or municipality may be enforced by any peace officer within that peace officer's jurisdiction. Note that this will not appear in a peace officer's "ticket book" since it is not an "infraction", but a "crime" (misdemeanor), subject to fine and imprisonment.

Section 23-48 of the CGS (as amended by PA 01-150):

Any person who kindles or directs another to kindle a fire in the open air, without proper authorization from state or local authorities or any person who burns materials that are prohibited from being burned by any provision of the general statutes, regulation of the state or local ordinance, shall be fined not more than two hundred dollars or imprisoned not more than six months or both.

Because a violation of 23-48 of the CGS has a fine or imprisonment as a penalty, it is an "offense"

Section 53a-24 Offense defined. (a) The term "offense" means any crime or violation which constitutes a breach of any law of this state or any other state, federal law or local law or ordinance of a political subdivision of this state, for which a sentence to a term of imprisonment or to a fine, or both, may be imposed, except one that defines a motor vehicle violation or is deemed to be an infraction. The term "crime" comprises felonies and misdemeanors. Every offense, which is not a "crime", is a "violation". Conviction of a violation shall not give rise to any disability or legal disadvantage based on conviction of a criminal offense.

Any "offense" subjects the person to arrest without warrant by a "Peace Officer" in that "peace officer's" jurisdiction.

Section 54-1f. Arrest without warrant. Pursuit outside precincts. (a) For purposes of this section, the respective precinct or jurisdiction of a state marshal or judicial marshal shall be wherever such marshal is required to perform duties. Peace officers, as defined in subdivision (9) of section 53a-3, in their respective precincts, shall arrest, without previous complaint and warrant, any person for any offense in their jurisdiction, when the person is taken and apprehended in the act or on the speedy information of others, provided that no constable elected pursuant to the provisions of section 9-200 shall be considered a peace officer for the purposes of this subsection, unless the town in which such constable holds office provides, by ordinance, that constables shall be considered peace officers for the purposes of this subsection.

Definition of a "Peace Officer"

(9) "Peace officer" means a member of the Division of State Police within the Department of Emergency Services and Public Protection or an organized local police department, a chief inspector or inspector in the Division of Criminal Justice, a state marshal while exercising authority granted under any provision of the general statutes, a judicial marshal in the performance of the duties of a judicial marshal, a conservation officer or special conservation officer, as defined in section 26-5, a constable who performs criminal law enforcement duties, a special policeman appointed under section 29-18, 29-18a or 29-19, an adult probation officer, an official of the Department of Correction authorized by the Commissioner of Correction to make arrests in a correctional institution or facility, any investigator in the investigations unit of the office of the State Treasurer or any special agent of the federal government authorized to enforce the provisions of Title 21 of the United States Code;

Connecticut Department of Energy & Environmental Protection Forestry Fire Hose Exchange Program

- How does the program work?
 - To perform a fire hose exchange, you must have notified the DEEP Fire Control Officer about the fire that the hose was used on, either using the Wildland Fire Reporting App, or a phone call. Next, it's a hose bag to hose bag swap, meaning 1 hose bag of 300' that was used to 1 hose bag of 300' that has been cleaned and tested.
 - Single lengths of hose may be exchanged on a case by case basis only.
 - Red hose bags must be provided with used hose.
 - If hose is damaged, turn in cut off couplings in order to be replaced with new hose.
 - Do not write or engrave fire department names or initials on hose or hose bags- it is not a guarantee that we will be able to get you that specific hose back to your department.

- How does the exchange occur?
 - The Fire Control officer will make arrangements to come to your department to perform the fire hose exchange.
 - Please loosely roll dirty hose or another easy hose roll method, to assist in ease of re-laying hose to be cleaned and tested.
 - The hose bag from the Fire Control Officer will include: 300' of cleaned and tested to standard for 1 ½" forestry hose. This hose is packed in a certain way which allows for the firefighter to connect the female end first to the truck, then carry the hose bag like a back pack to easily flake out the hose to the desired location of fire and easily connect nozzle to male end ofhose.
 - Please be advised it may take a few days for a response especially in busy times.



As a reminder for this year's fire season, attached you will find pertinent forms and information for Fire Bills including:

- A blank fire bill
- Approved compensation rates
- List of fire wardens statewide
- Corresponding area map.

The Division of Forestry will send a similar mailing to all Fire Wardens as well.

Things to remember about fire bills:

- The bills need to be submitted as soon as possible. Bills that are excessively late will be returned without payment. Bills must be submitted to the Fire Control Officer for their review prior to sending into Hartford for processing.
- Federal ID numbers for all businesses and Fire Departments must be listed on the Fire Bill.
- All supplies must be accompanied by an original itemized receipt, with the exception of foam, which is reimbursed at an established rate.
- Wardens must review and sign each bill. Wardens should ensure accurate information is reported. Please complete all fields, including GPS Coordinates. Incomplete bills may be returned, unpaid. <u>Do not</u> fill in the box designated for DEEP USE ONLY.
- <u>Do not</u> submit bills for paid Fire Departments.
- <u>Do not</u> submit bills that include time for out-of-state firefighters or firefighters on stand-by. Should you have any questions on fire bills, please contact Richard Schenk.

Dear Commissioner Geballe:

As State Forest Fire Warden I am requesting approval of revised compensation rates for Connecticut wildfire suppression personnel. Changes to these compensation rates require approval by the Commissioner of Administrative Services per CGS 23-39. This request is resultant of Connecticut's minimum wage increases per Public Act 19-4 from \$10.10/hr to \$11.00/hr effective October 1, 2019 followed by incremental increases to \$15.00 effective June 1, 2023. Additional increases effective January 1, 2024 will be based upon the employment cost index, or its successor index at which time we will revisit the compensation rates schedule. Volunteer fire departments may be reimbursed for wildfire suppression costs in accordance with CGS 23-36 provided a town ordinance exists to receive such payments.

The attached table details proposed changes increasing minimum wage rates for Unregistered Firefighters in 2019 through 2023 and prorates existing pay differentials for Registered Firefighters, Deputy Fire Wardens, and District Fire Wardens. With this approximate total 33% wage adjustment, estimated increases for all statewide expenses based upon five year annual averages are expected to remain less than \$5,000 per year through 2023. Equipment hourly rates are also proposed to increase based upon the 2019 FEMA Schedule of Equipment Rates and remain unchanged through 2023.

Equipment and vehicle rates are proposed to remain unchanged through 2023. However significant changes in future fuel cost may require review and request for revision.


