INVITATION TO BID – FOR THE SALE OF FOREST PRODUCTS  
SALE #E-1108**

**The State of Connecticut, Department of Energy and Environmental Protection (DEEP),  
Division of Forestry, offers the following forest products for public sale:**

- 1. DESCRIPTION:** Softwood sawtimber stumppage: 65,936 B.F. International 1/4" tree scale (see tally sheet). Hardwood sawtimber stumppage: 51,223 B.F. International 1/4" tree scale (see tally sheet). 354 cords hardwood firewood (see tally sheet). 23 cords softwood pulpwood. Trees to be purchased and harvested are marked with blue or orange paint at approximate head height and at stump level. If not utilized, all marked trees must be felled and lopped.
- 2. LOCATION:** Nipmuck State Forest, Compartment 13, Stand 1. The harvest area is located west of Breakneck Road (see map) in the town of Union, CT. The harvest area is approximately 45 acres.

**The BUYER will enter into a formal, written Sales Agreement with the State of Connecticut which includes, but is not limited to, the following obligations:**

**1. PAYMENTS & DEPOSITS:**

**(A) PAYMENTS:** One-fourth (1/4) of the bid amount will be due prior to harvest, but no later than the close of business on May 15<sup>th</sup>, 2026. One-fourth (1/4) of the bid amount will be due when trees have been cut on 15 acres, but no later than the close of business on December 4<sup>th</sup>, 2026. The balance will be due in full when in the opinion of the State's Monitoring Forester trees have been cut on 30 acres of the harvest site, but no later than the close of business on May 7<sup>th</sup>, 2027.

**Contract Expires: March 10<sup>th</sup>, 2028.**

**(B) PERFORMANCE DEPOSIT:** The BUYER shall post a performance deposit to the STATE in the amount of \$2,000 prior to the start of harvest operations, but no later than thirty (30) days after the Agreement has been executed by the State.

**2. WORK REQUIREMENTS:**

- The buyer is required to purchase, deliver, and spread up to 88 tons of 3" minus to improve Breakneck Road from the gate to the landing and to improve the landing.
- The buyer is required to provide, install, and maintain four (4) temporary crossing structures which will be used to cross three unnamed streams which flow through the harvest area. There is potential to add a fifth crossing on the westernmost stream, should it be deemed necessary (see map). Buyer is only allowed to cross the unnamed streams at locations approved by the supervising forester. Structures and associated corduroy will be removed at the conclusion of the harvest at the supervising forester's discretion.
- The buyer is required to corduroy sections of skid trail that become wet during the operation or at the supervising forester's discretion.





