INVITATION TO BID – FOR THE SALE OF FOREST PRODUCTS
SALE # W-443A

**The State of Connecticut, Department of Energy and Environmental Protection (DEEP),
Division of Forestry, offers the following forest products for public sale:**

- 1. DESCRIPTION:** Mixed Hardwood and White Pine sawtimber stumppage: 42,294 B.F. International 1/4" tree scale; 124 cords hardwood poletimber stumppage, and 2 cords of white pine poletimber stumppage (see tally sheet). Trees to be purchased and harvested are marked with orange paint at approximate head height and at stump level. If not utilized, all marked trees must be felled and lopped.
- 2. LOCATION:** Nassahegon State Forest, Compartment 7, Stand 1C. The harvest area is located on the east side of Stone Road in the town of Burlington, CT. The harvest area is approximately 20 acres.

The BUYER will enter into a formal, written Sales Agreement with the State of Connecticut which includes, but is not limited to, the following obligations:

1. PAYMENTS & DEPOSITS:

(A) PAYMENTS: One-fourth (1/4) of the payment will be due prior to harvest, but no later than the close of business on August 3, 2026. One-fourth (1/4) of the payment will be due when trees have been cut on 5 acres, but no later than the close of business on November 2, 2026. The balance will be due in full when in the opinion of the State's Monitoring Forester trees have been cut on 10 acres, but no later than the close of business on February 1, 2027.

The contract will expire on September 1, 2027.

(B) PERFORMANCE DEPOSIT: The BUYER shall post a performance deposit to the STATE in the amount of \$3,000 prior to the start of harvest operations, but no later than thirty (30) days after the Agreement has been executed by the State.

2. WORK REQUIREMENTS:

(A) The Buyer will deliver and spread 22 tons of 3" minus processed aggregate (or equivalent) on the driveway leading to the landing before trucking begins.

(B) Slash will not be left within 25 feet of the Blue Trail, Stone Road, or the southern boundary. Slash between 25-100 feet of the Blue Trail, Stone Road, or the southern boundary will be lopped to no higher than 4 feet.

(C) Harvesting, other than trucking logs from the landing, will be restricted to the hours of 7AM-5PM. There will be no harvesting within 500 feet of houses on weekends.

(D) If harvesting is conducted between April 1 and November 1, the Buyer will search the immediate area to be worked each day for Eastern Box Turtles before starting up. Turtles found during the harvest should be moved out of the way, just outside the work area. Avoid disturbing fallen logs and pits from tipped root mounds.

(E) Operator will follow standard BMPs for bats using soft start techniques on cool mornings with < 50° F overnight temperature if working in late spring/early summer or in late

autumn. Heavy equipment activity shall be introduced with a short initial representative action, the activity should then pause for 3-5 min to allow animals to leave the area before activity resumes. Repeat this soft start cycle for at least 20 mins.

Interested persons may inspect the harvest area in the company of a DEEP Forester on: **Wednesday February 4th at 9AM.**

The attached tally sheets are estimates only and not a guarantee of board foot or cordwood volume. The State reserves the right to reject any and all bids for any or no reason.




