The State of Connecticut, Department of Energy and Environmental Protection (DEEP), Division of Forestry, offers the following forest products for public sale:

- 1. **DESCRIPTION:** Hardwood sawtimber stumpage: 413,662 B.F. International 1/4" tree scale and 90 cords of hardwood stumpage (see tally sheets). Trees to be purchased and harvested are marked with blue paint at approximate head height and at stump level. If not utilized, all marked trees must be felled and lopped.
- **2. LOCATION:** Housatonic State Forest, Cream Hill Block, Stands A and B. The harvest area is located west of Cream Hill Road in the town of Cornwall, CT. The harvest area is approximately 48 acres.

The BUYER will enter into a formal, written Sales Agreement with the State of Connecticut which includes, but is not limited to, the following obligations:

1. PAYMENTS & DEPOSITS:

- (A) PAYMENTS: One-fourth (1/4) of the payment will be due prior to harvest, but no later than the close of business on March 3, 2025. One-fourth (1/4) of the payment will be due when trees have been cut on 12 acres, but no later than the close of business on August 1, 2025. The balance will be due in full when in the opinion of the State's Monitoring Forester trees have been cut on 24 acres of the harvest site, but no later than the close of business on October 1, 2025. The contract will expire on May 14, 2027.
- **(B) PERFORMANCE DEPOSIT:** The BUYER shall post a performance deposit to the STATE in the amount of \$4,000 prior to the start of harvest operations, but no later than thirty (30) days after the Agreement has been executed by the State.

2. WORK REQUIREMENTS:

- (A) Before trucking begins, the Buyer will be required to deliver and spread 110 tons of 3" minus processed aggregate (or equivalent) on the first 200' of Gold Road leading in from Cream Hill Road. The Buyer will be required to deliver and spread additional material on Gold Road and the landings to maintain the road in its current condition (smooth with minimal ruts).
- **(B)** Landings will be located at sites used in previous harvests. Logs may also be piled along Gold Road as needed. There will be no skidding on Gold Road unless permitted by the monitoring forester. Forwarders will be allowed to use Gold Road.

The Buyer is required to corduroy sections of skid or forwarder trail that become wet during the operation or at the monitoring forester's discretion.

- (C) There will be no operations within 100' of the seep identified on the W-448 Bid Invitation map.
- **(D)** Best Management Practices as described in Connecticut's BMP Manual shall be followed during the harvest operation.

(E) The Buyer will be made aware of the possible presence of Small Whorled Pogonia and be provided an Identification Guide.

<u>Interested persons may inspect the harvest area</u> in the company of a DEEP Forester **after** the showing for W-452A/B on Monday, November 4th, which begins at 9:00 am at Mansfield Road, Cornwall (41.915066, -73.305130)
