## APPLICATION FOR FREE TRIBAL MEMBER DEER PERMIT

Notwithstanding the provisions of section 26-27, any tribe member may take, hunt or trap any wild bird or quadruped on, or take or assist in taking any fish or bait species in the waters of, the reservation of [his] such tribe without a license therefore, subject to the regulations promulgated by the council and to such seasonal and bag limitations as may be provided by law. The Commissioner of Environmental Protection shall issue, without fee, a private land deer permit for use only on the reservation of the tribe provided such reservation is not less than two hundred fifty acres in size and provided further no such member shall be issued more than one permit per season. Such permit shall allow the use of a rifle, shotgun, muzzleloader or bow and arrow on such reservation land from November first until December thirty-first.

To apply for such permit, this application must be completed and signed. All tribe members must possess a valid Tribal ID, and the Tribal Land must be 250 acres or greater.
