Overview:

Public Act No. 98-157, Section 6 provides that the Commissioner of Environmental Protection shall submit a report to the joint standing committee of the General Assembly having cognizance of matters relating to finance, revenue and bonding and to the State Bond Commission each month. The report shall provide information on the acquisition of land or interests in land completed in the previous month by the state, a municipality, water company or nonprofit organization using funds authorized for the Open Space and Watershed Land Acquisition Program established by Public Act 98-157 and the Recreation and Natural Heritage Trust program established under Sections 23-73 to 23-79, inclusive, of the Connecticut General Statutes.

Open Space and Watershed Land Acquisition Grant Program:

The grant application deadline was October 30, 1998. Fifty-nine applications were received proposing to acquire approximately 5,000 acres of open space land at a total estimated cost of \$40 million. These applications are being evaluated, scored, and prioritized by DEP staff and a subcommittee of the Natural Heritage, Open Space and Watershed land Acquisition Review Board. The review process is nearly completed and awards will be announced in January 1999.

No acquisitions have yet occurred pursuant to this program.

Recreation and Natural Heritage Trust Program:

The Recreation and Natural Heritage Trust program is the State of Connecticut's primary program for the acquisition of lands for the beneficial use and enjoyment of the public as additions to the State's system of parks; forests; wildlife, fisheries and natural resource management areas. The program is intended to acquire land that represents the ecological diversity of Connecticut, including natural features such as rivers, mountainous areas, coastal systems and other natural areas, in order to ensure the preservation and conservation of such land for recreational, scientific, educational, cultural and aesthetic purposes.

Open Space and Watershed Land Acquisition Grant Program:

The DEP has mailed a notice to all Connecticut municipalities, nonprofit land conservation organizations and water companies to solicit grant applications for the "Fall" grant round to allocate \$6 million approved by the State Bond Commission on September 24, 1999. The deadline for submission of grant applications is November 19, 1999. The DEP anticipates continued strong interest in the program. During Fiscal Year 1999 applications were received to acquire over 6,700 acres at a acquisition cost of \$37 million.

Recreation and Natural Heritage Trust Program:

The Recreation and Natural Heritage Trust program is the State of Connecticut's primary program for the acquisition of lands for the beneficial use and enjoyment of the public as additions to the State's system of park, forest, wildlife, fisheries and natural resource management areas. The program acquires land that represents the ecological diversity of Connecticut, including natural features such as rivers, mountainous areas, coastal systems and other natural areas, in order to ensure the conservation of such land for recreational, scientific, educational, cultural and aesthetic purposes.

The DEP has established a review process to evaluate possible acquisitions. All potential acquisitions are reviewed and scored by the resource management divisions of the DEP based upon criteria established by each management division as significant to their program. The review process and selection criteria are rigorous to assure that only significant resource management properties are acquired. During Fiscal Year 1999 the DEP rejected sixty percent of the properties suggested for acquisition.

The DEP Division of Land Acquisition and Management has a current working project list of eighty-seven properties representing approximately 9,910 acres under active negotiation with an estimated fair market value of \$33 million.

The DEP has mailed a notice to all Connecticut municipalities, nonprofit land conservation organizations and water companies to solicit grant applications for the "Fall" grant round to allocate \$6 million approved by the State Bond Commission on September 24, 1999. The deadline for submission of grant applications is November 19, 1999. The DEP anticipates continued strong interest in the program. During Fiscal Year 1999 applications were received to acquire over 6,700 acres at a acquisition cost of \$37 million.

Overview:

Public Act No. 98-157, Section 6 provides that the Commissioner of Environmental Protection shall submit a report to the joint standing committee of the General Assembly having cognizance of matters relating to finance, revenue and bonding and to the State Bond Commission each month. The report shall provide information on the acquisition of land or interests in land completed in the previous month by the state, a municipality, water company or nonprofit organization using funds authorized for the Open Space and Watershed Land Acquisition Program established by Public Act 98-157 and the Recreation and Natural Heritage Trust program established under Sections 23-73 to 23-79, inclusive, of the Connecticut General Statutes.

Open Space and Watershed Land Acquisition Grant Program:

The DEP has received twenty-six requests from twenty municipalities and six private nonprofit land conservation organizations proposing to spend \$20,791,136 to acquire over 1,880 acres in open space projects. Nine of the proposals will directly protect water quality and five will provide for continued agricultural use. The deadline for submission of grant applications was November 19, 1999. The DEP, together with other state agencies and the Natural Heritage Open Space and Watershed Land Acquisition Review Board, will be evaluating the project proposals. Grant awards are expected to be announced in January, 2000.

Public Act No. 98-157, Section 6 provides that the Commissioner of Environmental Protection shall submit a report to the joint standing committee of the General Assembly having cognizance of matters relating to finance, revenue and bonding and to the State Bond Commission each month. The report shall provide information on the acquisition of land or interests in land completed in the previous month by the state, a municipality, water company or nonprofit organization using funds authorized for the Open Space and Watershed Land Acquisition Program established by Public Act 98-157 and the Recreation and Natural Heritage Trust program established under Sections 23-73 to 23-79, inclusive, of the Connecticut General Statutes.

Open Space and Watershed Land Acquisition Grant Program:

The grant application deadline was October 30, 1998. Fifty-nine applications were received proposing to acquire approximately 5,000 acres of open space land at a total estimated cost of \$40 million. These applications are being evaluated, scored, and prioritized by DEP staff and a subcommittee of the Natural Heritage, Open Space and Watershed land Acquisition Review Board.

No acquisitions have yet occurred pursuant to this program.
