Chairman's Report - No report

Legislative Report -

- SB 424 which would reauthorize the CT Recreational Trails Grants Program was discussed. There will be a public hearing on Friday 3/16, the CGC was encouraged to submit testimony in support of this bill and attend the hearing if possible.
- HB 5485 An act concerning electric bicycles and urban traffic safety. NEMBA representatives on the phone explained that this bill, though largely beneficial to bicycles on roads, would allow "...electric bicycle may be ridden where bicycles are permitted to travel" which could result in ebikes riding on any trails. It was noted that State Parks currently considers an ebike a motorized use which would be prohibited from most state park multi-use trails. It is uncertain whether this legislation would supersede current State Parks policy. The CGC was encouraged to submit testimony in opposition to this raised bill. Rista provided a link to an American Trails webinar on ebikes. There was much discussion on classes of ebikes. There was a motion made by Joe Hickey and after discussion, second by Bob Dickinson to: Support existing State Park policy on multi-use trails. The motion passed.

CT DOT and Bike-Ped (BP) Advisory Committee – Jim Kulpa noted that the Bloomfield Greenway project will be advertised soon.

Old Business -

- > <u>CT Recreational Trails Program</u> covered under legislative report.
- Planning Greenways Day June 1. Laurie solicited input from the CGC via email following the meeting. Suggestions for holding this event in North Eastern-Eastern CT were received. America is celebrating the 50th anniversary of the National Trails System Act as well as the Wild and Scenic Rivers Act. We have all of these in Eastern CT. Also, we have an application from the Avalonia Land Trust for a new designation that will likely be made. Julie-Duponte Woody representing the Avalonia Land Trust and the Town of Ledyard's Conservation Commission gave a brief presentation to request hosting the event at the Ledyard Historical Nathan Lester House. There was some discussion and a motion by Joe Hickey to hold the 2018 event at the NLH in Ledyard, Jamie and Lois second and all approved. The motion passed. Laurie will email CGC past award list so we can begin compiling nominations for this event and vote at the April meeting.
- Planning Trail Symposium October 25th. Laurie will solicit input from the CGC via email
- Figure 2. Greenways License plate Bill O'Neill reported that he is working with Rep. Guerra and others in the next couple of weeks. He requested more names of potential legislators who the CGC members believe would be supportive to be sent to him.
- Recruitment of Secretary and Vice-Chair update Rista volunteered and was accepted by the Chairman as Vice-Chair. A suggestion was made to designate a secretary at each meeting and keep the position rotating. This will be tried at the April meeting.
