Minutes of Meeting June 13, 2023 Via Zoom

A regular meeting of the CT Greenways Council was held Tuesday, June 13, 2023 via ZOOM. The agenda was published on the website and invitees prior to the meeting. Meeting link details were sent to invite list by Kim Bradley several days prior.

Present were council members: Bruce Donald (Chair), Rista Malanca, Paula Burton, Claire Cain, Bob Dickenson, Cathy Hagadorn, William O'Neill, and Ex-Officio members Kim Bradley and Anna Bergeron.

Bruce established a quorum and called the meeting to order at 9:03. Audio recording was started at 9:02.

- Adoption of minutes.
 - 1. May 9th minutes were sent the night prior as attachments, call for additions. No Discussion.
 - 2. Motion to accept with possible updates via Bruce Donald (BD). Made by Rista Malanca (RM), Cathy Hagendorn, (CH) seconded.
 - 3. Passed unanimously.
- Chairman's Report Bruce Donald.

Legislative session is completed.

- 1. Vision Zero HB5917 (Now Public Act 22-116) passed with some elements missing from earlier versions.
 - a. Includes "Red Light Cameras" with several conditions.
 - i. Municipalities can enact cameras.
 - ii. Cameras for DOT worksites up and running.Anna Bergeron (AB) indicates its being addressed by DOT.
 - iii. Locations have to be reviewed by legislature.
- 2. Senate Bill 998 passes.
- 3. AN ACT ESTABLISHING A TAX ABATEMENT FOR CERTAIN CONSERVATION EASEMENTS. To authorize municipalities to exempt from real property taxes any portion of land that (1) qualifies as a greenway, (2) is a terrestrial recreational trail that does not exceed one hundred feet in width, (3) is the subject of a conservation easement conveyed by the owner of the land to a municipality, the state or a

nonprofit land conservation organization, and (4) to specify that a greenway trail corridor may be deemed open space land.

- a. BD indicated that this has much more implication for rural communities.
 - Claire Cain (CC) indicated this is a game changer!
 - Looking for a town to be a 'beta' tester.
- b. C will provide 'talking points' to share and guide
- c. CH asked HOW do HOA's deal with this? How do communities work to motivate them?
 - BD indicated that they should qualify in theory.
- d. Value of property needs to be defined.
 - Kim Bradley (KB) Need to estimate \$\$ value for property values.
- 4. \$10MM/year (2 years) Rec Trails funding passed within bonding package.
- 5. ROW acquisition is back and available as a policy (per AG's Office) at DOT for trails.
 - a. Plainfield/Southington contacted Bruce.
 - i. July 20th public meeting Zoom announcement will be sent.
- DOT Anna Bergeron.
 - 1. Putman Bridge Trail opening April 15th 2024.
 - a. Ahead of schedule
 - 2. Manchester/Charter Oak
 - a. DOT signed PAL (Project Authorization Letter) agreement
 - b. Town will handle maintenance.
 - c. Use of State Conductivity Funds.
 - 3. Renegotiation of contracts with maintenance agreements where missing/not clear/not done previously.
 - a. Need to include now.
 - b. IF work needs to be done (without agreement) it will be done, IF town signs a PAL to continue maintenance.
 - c. BD: upper piece of FHCT (East Granby) is an example.
 - 4. Avon starting to make improvements as P.Z. using CT LOTCIP funding.
 - a. Old Farms road alignment.
 - 5. BD indicated a public hearing will take place in Pomfret for the ALSPT resurfacing program.
 - a. Jim Kulpa (JK) indicated that there is a month or 2 delay in meeting then 4/1/25 start estimate.

Southington FHCT Pre-construction meeting scheduled. Schultz got the construction contract. Moosup Valley State Park Trail bids are in for construction starting this fall.

- 6. BD indicated that generally, actual construction costs are coming in 30% higher than Engineers estimates.
