Adoption of Minutes - November minutes approved. Bill O/Bob D motion

Chairman's Report – Bruce Donald reported on:

- Significant funding has been pulled back from DOT affecting key sources for trails and related projects. Details under CTDOT report below.
- Bill O'Neill reminds all that "return on investment" is a critical benefit of trail projects which should always be included in conversations with legislators, funders, etc.. Raised the question should the Transportation Committee in CT co-sponsor any efforts to restore CRTP funding. CGC members discussed and will work toward support vs. co-sponsorship. Asked that CT Tourism be invited to the next CGC meeting.
- Bruce noted private foundations have been significant sources of trail project funding in other New England states.
- Reminder that there are many economic studies available as resources on the <u>CGC website</u> and the <u>CT Trail Census</u> website.
- The East Coast Greenway <u>Bike-Walk Summit</u> will be in Boston this year April 26-27. All are encouraged to attend.
- Going into the New Year, Bruce is pleased to be working with the CGC and looking forward to a productive year. He is recruiting for Vice Chair and Secretary Positions. Contact him if you are interested.

Correspondence – Laurie has had conversations with NEMBA regarding statewide single-track network planning as a result of their comments on the DEEP SCORP.

CT DOT and Bike-Ped (BP) Advisory Committee – Anna B reported that many of the State DOT's programs that fund trails has been pulled back. Examples include Community Connectivity, Local Transportation Capital Improvement Program (LTCIP), Lets Go CT. The TA program is federally funded and still up and running. DOT operating funding from the State Bond Commission remains their priority. Bike-Ped Projects that are "shovel ready" and funded will move forward; no new projects.

Legislative Report – Special Session began today and will likely conclude in a day or two. Regular session begins Feb 7 ends May 9. Bill O will be working to get the CT Greenways Plate legislation restored.

Old Business -

- > CT Recreational Trails Program Update on strategy to restore funding. Eric Hammerling & Bruce reported that the CGC goal will be to restore \$7million. Two steps involved to restore the program: authorization and allocation of funding. CFPA is currently leading the work with CGC on authorization. The Environment Committee introduced the original legislation and so the goal is to work with that committee's chairmen to re-introduce the enabling legislation. Meetings will be set up soon and Bruce will be invited. Once the legislation/authorization is accomplished, CGC will have to work to get the Bond Commission to add the item to their agenda, and to insure DEEP's support to allocate funding.
- Merritt Parkway Greenway Bruce reported that he will be attending a DOT meeting likely this month. Bill O suggests that CGC focus advocacy on building the Stamford mile first.
