# Minutes of Board Meeting January 12, 2015

**Adoption of Minutes** Nov 2014 meeting approved.

### Chairman's Report – Bruce Donald

Thanks to David Gumbart for his time served on the Council, he has submitted his resignation and will be missed.

Rista Malanca is our new member representing the Naugatuck River Greenway and she introduced herself.

Bruce requested to move through his priority items due to his time constraint; a meeting with Congresswoman Esty this morning. The items covered were under Old Business and summarized below.

## CT DOT & Bike/Ped Advisory Comm. – Kate Rattan


DOT's legislative review is underway. Kate will be able to provide Bill numbers for the Council to consider. RR Liability issue may be a common interest with the CT River COG who are studying CT Valley RR corridor. There may be revisions proposed to strengthen the current multi-user bill. Bruce will contact Kelly Kennedy, of Bike Walk CT, to discuss collaboration on support of that issue.

Governor's State of the State is on CTN and did include focus on transportation with bike/ped priorities. DOT priority is the East Coast Greenway and regional trails that would link to it; consequently, for example, a single track foot trail would not be a priority but multi-use, ADA compliant would be.

The Town of Plainville may be receiving \$625,000.00 for a planning/design project to complete the Farmington Canal Heritage Trail in town. Kate reported that this project is now under review at DOT. The funding manager is in question at this time due to the re-org of former RPA and may be managed by CRCOG. Timing, funding may be in place by Sept. Bruce reported that the Farmington Valley Trails Council is focused on facilitating this project in any way.

Acting upon a request by the user community, and working with DEEP, DOT has opened up the Comstock Bridge in Colchester to equestrians.
