Acceptance or Revisions to Agenda - Amy Watkins was added to discuss "Watch for Me"

Adoption of Minutes - January minutes approved. Joe Hickey/Charlie Taney

Chairman's/legislative Report – Bruce Donald reported on:

- Still seeking Vice Chairman and Secretary.
- Mileage added to the ECG in Cheshire, Plainville and Cheshire.
- Bruce and Eric Hammerling met with Mike Demicco, State Rep head of the Environment Committee. Requested bill to re-authorize the CT Rec Trails Program at 10 million. Vote should happen in the coming months. Joe Hickey raised the importance of the Gov support.
- Kevin Tedesco asked for clarification on last grant round 9.4 million "shovel ready"? That term is misleading as design and planning projects are also eligible under the grant program.
- Kate Rattan commented that construction prices continue to increase and current funding sources for trail projects are insufficient. Recommended a diversification of sources be researched.
- Bruce asked if DEEP is considering return to the national program; LG "no".
- Charlie Taney asked when public input will be needed to assist with re-authorization of CT RTP. Bruce will be notifying folks and providing talking points.

Correspondence – **Laurie** has received many calls re the status of the CRTP. She has been collecting names of folks who responded to this answer from Laurie: "There is no funding available. However, The CT Greenways Council (CGC) is working with our legislators to re-authorize the program. If successful, we hope to announce a grant round this September in anticipation of funding for the re-authorized program. The CGC will be soliciting the trail community for support of the funds. If you are interested in assisting I will add you to their distribution list."

CT DOT and Bike-Ped (BP) Advisory Committee – Anna B reported no change from the last meeting report.

Old Business -

- CT Trail Census presentation of results; Kristina Kelly, CT Trail Census Statewide Coordinator. (notes attached); Webinar scheduled for April 3rd and press releases to follow.
- Greenways License plate Bill O'Neill reported that he is working with Rep. Guerra and others in the next couple of weeks. He requested more names of potential legislators who the CGC members believe would be supportive to be sent to him.
- Merritt Parkway Greenway Bruce reported that he has seen the DOT study. Stamford, Fairfield and Trumbull are candidates for pilots.
- Bike Lockers Bill O is beginning this discussion for Manchester including STC certificate strategy.

New Business -

- Begin planning Greenways Day June 1. Laurie will solicit input from the CGC via email.
- Begin planning Trail Symposium October 25th. Laurie will solicit input from the CGC via email
- Amy Watkins, Program Coordinator, presentation on "Watch for Me" (notes attached). Seeking input from CGC on messaging plan for their 2018 outreach campaign. Bruce and Joe suggested their advocacy for separated bike/ped vs. car. Amy noted they cannot advocate for specific legislation because of their nature. Bruce requested crash & injury data. Amy would like to attend CGC member events if possible.
- Charlie Taney requested assistance from CGC and others present who have experience with DOT challenges presented for potential municipal has mat issues in trail ROWs.
