
Average Food Waste Nation Wide by Source

## **Food Recovery Hierarchy**

Source Reduction Reduce the volume of surplus food generated

### Feed Hungry People

Donate extra food to food banks, soup kitchens and shelters

Feed Animals Divert food scraps to animal feed

#### Industrial Uses Provide waste oils for rendering and

fuel conversion and food scraps for digestion to recover energy

### Composting

Create a nutrient-rich soil amendment

Landfill/ Incineration Last resort to disposal



# Organics Recycling Law (CGS 22a-226e)


- 2011 Legislation passed CT was the first state to adopt a program.
- 2014 Start date
- Applies to food wholesalers, distributors, manufacturers, processors, supermarkets, resorts & conference centers that:
- Generate 104 tons/yr (2 tons per week) of source separated organics, <u>and</u> are
- Within 20 miles of a permitted food waste processing facility.



# Organics Recycling Law (CGS 22a-226e)

- Generation volume reduces to 52 tons/yr in 2020 (1 ton per week)
- Smaller generators will benefit due to creation of more options to recycle food waste




