

- Permit Assistance has been offered for many years in CT
- Concierge services are an emerging amenity in many states
- Some impactful areas to improve user experience:
 - Automated services may help balance staff resources
 - Transparency with processes, timeframes, and fees

PERMIT ASSISTANCE PROCESSES & PROCEDURES

Concierge / Permit Assistance Services

California Air Resources Board (CARB)

- Statewide planning group
- Offers visiting speaker to present issues/permits - request by submittal of form
 - Stakeholder engagement providing outreach including virtual webinars on legislative topics and current issues
- Compiles resources on CA air permitting (i.e., resources on website, brochures, fact sheets)
- Allocates funds to CA Air Districts to be used as incentives for replacement, rebates, vouchers for lower CO2 emissions equipment

California Air Districts (35)

- Functions similarly to CT DEEP BAM
- Hands-on individual permit application assistance for clients by staff equivalent to CT DEEP Engineer of the Day
- Citizen Advisory Board equivalent to CT DEEP's SIPRAC, HWAC, SWAC, Remediation Roundtable

Permit Packaging

California Permit Grouping

- Only for water permitting & occurs through the California State Water Resources Board
- Permits cover "multiple facilities within a specific category" or permitting by function Examples include:
 - Facilities that "discharge the same type of wastewater"
 - Facilities that "use the same type of operations"
- Can be used to issue multiple permits together in a group, provided they have the same owner



PERMIT ASSISTANCE PROCESSES & PROCEDURES

"Fast Track" Permitting - Massachusetts

"helps businesses get answers faster while ensuring protection of our natural resources"

- Currently available in Western Region only
- Independently coordinated by one manager in charge of all types of permits
- Permit fees paid upfront with a memorandum of agreement outlining permit deliverables and timeframes consistent with client's timetable
 - additional costs included for public hearings, staff overtime to meet deadlines, etc.
- MA Fast Track Eligibility for certain projects (similar to CT Concierge):
 - Project types biotech, energy, transit-oriented development, brownfield redevelopment, solid waste recycling facilities, smart growth
 - Projects consistent with sustainable development principles and promoting smart growth
 - Projects determined by the Commissioner to be of significant environmental interest to the Commonwealth
 - Projects with multi-permit complexity



PERMIT ASSISTANCE PROCESSES & PROCEDURES

FAST TRACK
PERMITTING

"Fast track" in other states?

- MA only, and only in Western District
- MADEP
 - All costs paid up front based on pre-app
 - One permit manager for all permits
 - Fast track by district/region only works in Western District*
- Enables applicant to have certainty for project start date
- Timely permitting may be incentivized through submittal of package of applications and fees up front
- Packaged applications may support processing speed

FACT SHEET

Information for Solar Developers

An Environmental Permitting Factsheet



This Factsheet provides information on the types of permits that may be required and the timing and sequencing of those permits to developers who are proposing to install solar energy generating facilities. Pre-application permit assistance, where applicants can meet with permit program staff to discuss a specific project, is available. To request a pre-application meeting, please complete the Pre-Application Questionnaire and submit it to DEEP.OPPD@ct.gov. This Factsheet should be used in conjunction with the DEEP Bureau of Energy

and Technology Policy's Integrated Resource Plan Renewable Siting Recommendations.

I. Natural Diversity Data Base (NDDB) – At the outset of a project, it is necessary to determine if there are known occurrences of any state or federally-listed species within the impact area of the project site (Section 26-306 of the Regulations of Connecticut State Agencies). DEEP recommends conducting an initial site evaluation to assess the potential to support state-listed species. Developers will then need to determine if their project is an area with documented state-listed species; maps can be found at https://portal.ct.gov/DEEP/Endangered-Species/Natural-Diversity-Data-Base-Maps. If in a documented area, consultation with DEEP's NDDB staff will be required to agree upon impact-avoidance and protection measures. Protection measures will be included in a determination letter from DEEP; this letter must be included with filings for other state permit

Transparent Timeframes & Fees

- Similar to CT, but CT info not all in one place

Permitting Overview: Air Emissions

Clean Air Interstate Rule

New Source

Minor Modification Application for an Existing New Source Review Permit

Fees: Beginning at \$3,250 for new minor sources (includes \$940.00 application fee)

Public Notice: nitial notice of application - AND - Notice of Tentative Determination (30 days). EJ,

if in applicable area.

Estimated Processing Timeframe: 5 months for new minor source / 12 months for new major source

Type of Permit: Individual
