## First Destination of Municipal Solid Waste (MSW) Disposed from Each CT Municipality in FY2010

**Disposal tonnages** presented in the table below represent both residential and nonresidential MSW and are based on data submitted to the Connecticut Department of Energy and Environmental Protection as of 9/7/2012 by: Connecticut municipalities, and the following types of Connecticut permitted solid waste facilities: (1) regional multi-town transfer stations (TSs); (2) single town municipal TSs which transferred waste to out-of-state destinations; (3) landfills; (4) C&D VRFS which reported oversized MSW separately from C&D waste; and (4) Resource Recovery Facilities (RRFs). If the first destination was a single town municipal TS, the first destination represented below is the destination after the municipal TS. Data does **not** include construction and demolition (C&D) waste or oversized MSW received at C&D volume reduction facilities (unless the C&D VRF reported oversized MSW separately from C&D waste) and does **not** include waste recycled, reused, or composted.
