

## Solid Waste Reported Transferred Out from Connecticut Municipal Solid Waste Resource Recovery Facilities (RRFs - Waste-to-Energy Facilities)

Tonnages presented in the table below are based on data submitted to the Connecticut Department of Environmental Protection by [CT RRFs](#) as entered into the Connecticut Department of Environmental Protection Solid Waste Database as of 11/24/2009

### Definitions as used in this report:

- **Ash** –Ash, air pollution control residue and other residuals generated by the combustion process at a Resource Recovery facility (RRF). In FY2008 an average of approximately 25% (by weight) of the waste burned at CT RRFs was converted to ash and buried in landfills.
- **By-pass Waste** – Waste delivered and weighed at a RRF but never processed (e.g. not sorted, burned, etc.) at the RRF and sent elsewhere for disposal. This can occur during routine maintenance or when the facility receives more waste than it can process.
- **Metal - Post-Comb** – Metal recovered for recycling from RRF Ash.
- **Metal - Pre- Comb** – Metal recovered from waste before it is combusted at an RRF.
- **MIDCT Non-Processibles** – This term only pertains to the MidCT RRF (a refuse-derived-fuel RRF) and is used to describe waste that cannot be combusted at the MidCT RRF because of its large size and must be sent elsewhere for disposal.
- **MIDCT Process Residue** - This term only pertains to the MidCT RRF, a refuse-derived-fuel (RDF) RRF. Waste received at the MidCT RRF needs to be processed into RDF before it can be combusted. The residue generated during this processing is referred to as “process residue” and consists of MSW less than 1” in particle size and need to be disposed elsewhere..
- **Non-Ash Residue** – Residue from waste received at an RRF, processed, but not burned at the RRF
- **Resources Recovery Facility** – A facility utilizing processes to reclaim energy from municipal solid waste. Solid waste is incinerated, energy is generated, and ash is produced.
