Update Regarding LEP Renewals. There are 331 licensed LEPs as of July 1, 2022. This takes into consideration retirement from the program of seven LEPs and the addition of nine newly licensed LEPs.

- 1. **Item Development Call for Volunteers**. **Needed are two board members** to join two LEPs from the public (Mike Granata and John Carroll) and two DEEP employees (Kevin Vanderveer and Jeff Brais) in development of questions for the LEP exam bank. This exercise will take place on two or three days remotely between September 6th and the 16th depending on availability of participants.
- 2. Test Assembly Call for Volunteers. Needed are two board members, to join two LEPs from the public (Karen Goldenberg and Tim Burke) and two DEEP employees (Kevin Vanderveer and Jeff Brais) in assembling the next LEP exam to be administered in mid-May 2023. This exercise will take place on two or three days remotely between October 11th and the 21st depending on availability of participants.
- 3. **On-demand remote learning approval status requested by Alpha Analytical** with an updated application as requested by the board at the June 9th, 2022, meeting.
- 4. **9.5 CECs maximum possible (with 21.5 in options) requested by the South Atlantic Well Drillers for in person conference** to be held July 30th through August 1st, 2022, titled, "South Atlantic Jubilee."
- 5. **Request from an aspiring LEP applicant.** The individual will have 8 years of professional experience in April of 2023. However the application deadline is in February. They claim 4 years of responsible charge. Should they wait until 2024?
