MINUTES

State Board of Examiners of Environmental Professionals

Regular Meeting – October 13, 2016

A. Call to Order and Sign-In

A regular meeting of the State Board of Examiners of Environmental Professionals ("the Board") was called to order on Thursday, October 13, 2016 at 9:35 AM in the Russell Hearing Room on the 3rd floor, 79 Elm Street, Hartford, by Chair D. Ruzicka. Board members J. Adams, J. Loureiro, A. Phillips-Griggs, E. Patton and M. Gamache were present. Board Administrator Kim Maiorano was present and Board member S. Holtman was present on the phone. David Wrinn representing the Board/Attorneys General Office, Nelson Walter representing the EPOC and Jacques Gilbert of DEEP were present in person.

B. Reading and Approval of the Minutes

The draft minutes of the Regular Board meeting of September 8, 2016 were read and approved with minor corrections; motion by J. Loureiro, seconded by M. Gamache, passed unanimously with E. Patton and A. Phillips-Griggs abstaining.

C. Public Participation

Nelson Walter representing EPOC reported that Evan Glass had been elected to serve as President of EPOC.

D. Unfinished Business and General Orders

Update on complaint #16-101

S. Holtman and D. Wrinn provided a summary of the complaint and the consent order. The consent order calls for additional education (two courses pertaining to site characterization/investigation) and peer review of the next Verification provided by the LEP. A motion to accept the consent order as presented was made by S. Holtman and seconded by J. Loureiro was passed unanimously with J. Adams abstaining.
