DRAFT MINUTES

State Board of Examiners of Environmental Professionals

Regular Meeting - October 10, 2019

A. <u>Call to Order and Sign-In</u>

A regular meeting of the State Board of Examiners of Environmental Professionals ("the Board") was called to order on Thursday, October 10, 2019 at 9:40 AM in the Russell Room on the 3rd floor, 79 Elm Street, Hartford, by Chair Kenneth Collette.
