## **Regular Meeting – December 9, 2021**

## A. <u>Call to Order and Sign-In</u>

A regular meeting of the State Board of Examiners of Environmental Professionals ("the Board") was called to order on Thursday, December 9, 2021 at 9:35 via a Zoom conference call, by Chair Kenneth Collette. ### **Board Retirement Announcements**

## Update on Complaint 21-101 & 21-102
