**Review of LEP Renewal Applications**

Request to authorize Commissioner to issue licenses to those who filed timely and sufficient renewal applications.

Request to authorize Commissioner to waive the deadline and issue licenses to those who requested a waiver of the deadline and filed a sufficient renewal application after June 1, 2021 but before June 14, 2021.

Request to authorize Commissioner to waive the deadline to those who requested a waiver, apply a 10% late fee, and issue licenses to those who filed a sufficient renewal application on or after June 14, 2021 but before July 1, 2021.

Any renewal applications submitted untimely and insufficient expire as a matter of law on July 1st.

All renewal applications for licenses must be accompanied by certificates for 24 CECs, with the exception of the December 2020 LEPs (12 CECs).
