MINUTES

State Board of Examiners of Environmental Professionals

Regular Meeting – July 8, 2021

A. <u>Call to Order and Sign-In</u>

A regular meeting of the State Board of Examiners of Environmental Professionals ("the Board") was called to order on Thursday, June 10, 2021 at 9:37 via a Zoom conference call, by Chair Kenneth Collette. Board members J. Adams, D. Wolfram, M. Gamache, K. Meloy and R. Good were present via Zoom. Board Administrator Liz McAuliffe, Jacques Gilbert, and Selena Thornhill-Moody of DEEP, and Nelson Walter representing EPOC were also present on the Zoom call for the meeting. This meeting is being held via Zoom due to the Covid-19 pandemic and the Governor's Executive Orders prohibiting the physical gathering of persons.
