## State Board of Examiners of Environmental Professionals

## Regular Meeting – February 17, 2022

## A. <u>Call to Order and Sign-In</u>

A regular meeting of the State Board of Examiners of Environmental Professionals ("the Board") was called to order on Thursday, February 17, 2022 at 9:34 via a Zoom conference call, by Chair Kenneth Collette. Board members J. Adams, M. Gamache, D. Fiereck, L. Muratore, R. Good, C. Violette, R. Dirienzo and D. Wolfram were present via Zoom. Board Administrator Liz McAuliffe, and Jacques Gilbert of DEEP, Seth Molofsky and Nelson Walter representing EPOC were also present on the Zoom call for the meeting. This meeting is being held via Zoom due to the Covid-19 pandemic and the Governor's Executive Orders prohibiting the physical gathering of persons.

## B. Reading and Approval of the Minutes

The draft minutes of the Regular Board meeting of January 13, 2022 were read and approved with minor corrections; motion by M. Gamache, seconded by D. Wolfram, passed unanimously with R. Dirienzo abstaining.

### C. Public Participation

Mr. Walter and Mr. Molofsky thanked Board Administrator L. McAuliffe for her assistance in providing information concerning past exam passing rates as broken down by domains. Mr. Molofsky indicated EPOC's concern that the passing rates were so low. The Board took note of these concerns and hopes to address a restructuring of the exams through the next contract revision. EPOC will continue to work with the Board on issues related to the exam.
